Post 209 Bylaws Change.

Post 209's Bylaws Article X, Meetings, Section 5 that read: "Ten percent of the members in good standing shall constitute a quorum for the conduct of business at a regular or special meeting"

Was changed to read: "At least twelve or more members in good standing shall constitute a quorum for the conduct of business at a regular meeting and three of the twelve must be elected members of the Executive Committee."

This change was voted upon by a quorum of members at the March 13, 2004 General Membership meeting.

Members are still needed to attend official business meetings regardless of the above Bylaw change. Input by members is need for the Executive Committee to meet member expectations. Make it your business to attend meetings.

Duties of Officers (Ref. - Article IV of Post 209's Bylaws)

- <u>Section 1 The Post Commander</u> is the chief executive officer of the post and shall preside at all meetings of the post and have general supervision over the business and affairs of the post. He shall approve all orders directing the disbursement of funds, and shall make an annual report covering the business of the post for the year and recommendations for the ensuing year. This report shall be presented at the annual meeting, and a copy thereof immediately forwarded to the department adjutant.
- Section 2. The Senior and Junior Vice Commanders are the principal assistants to the Post Commander, and shall assist the Post Commander as directed in the discharge of his duties. In the event of the death, resignation or disability (declared by the Executive Committee to exist)) of the Post Commander, the Senior and Junior Vice-Commanders, in order of precedence, shall succeed to the office and have all the powers and duties of the Post Commander.
- <u>Section 3 The Adjutant</u> shall have charge of and keep a full and correct record of all proceedings of all meetings; keep such records as the department and national organizations may require; render reports of membership annually or when called upon at a meeting; and under the direction of the commander handle all correspondence of the post.
- <u>Section 4 The Finance Officer</u> shall have charge of all post funds and see that they are safely deposited in a local bank, and shall report once each month to the Executive Committee and to the general membership on the financial status of the post. He shall sign all checks disbursing the moneys of the post. He shall furnish surety bond in such sum as shall be fixed by the Executive Committee.
- <u>Section 5 The Historian</u> shall maintain a historical record of events of the post and of its members, and shall perform such other duties as may properly pertain to the officer as determined by the Executive Committee.
- <u>Section 6 The Chaplain</u> shall be charged with the spiritual welfare of the post and its members, and will offer non-sectarian divine services in the event of dedications, funerals, public functions, etc., adhering to such ceremonials rituals as are recommended by national or department headquarters.
- <u>Section 7 The Sergeant at Arms</u> shall preserve order at all meetings, and shall perform such other duties as may be assigned by the Executive Committee.
- <u>Section 8 The Post Service Officer</u> shall be responsible for bringing to the attention of all members and their dependents the rights and benefits available to them by law, and for assisting all veterans and their dependents in applying for such benefits. He must be familiar with laws and regulations governing veterans benefits, and with the service available from The American Legion Department Service Officer and from other community agencies.
- <u>Section 9 The Executive Committeeman</u> is a voting member of the post Executive Committee which is entrusted with the government and management of the post. It shall be his responsibility to represent the interests of the general membership on the Executive Committee.
- <u>Section 10 The Judge Advocate</u> shall be responsible for auditing post finances in accordance with the post Constitution. He shall also be responsible for interpreting the Constitution and Bylaws of the post, and when called upon to do so by the Commander or other officers of the post, to rule upon the legality of proposed actions or decisions.
