### A Day to Remember

Sunday, December 7, 1941, "A day that will live in infamy." With these words, President Roosevelt set in motion the beginning of WWII and a day that will live in the minds of Americans for generations to come. The attack on the US fleet at Pearl Harbor was the beginning of a change in the American way of life that is present even today. As Pearl Harbor survivors gather to honor those who made the supreme sacrifice on that fateful day, so we should take a moment to reflect on our lives and service to this great nation. If you were born before 1941, where were you and what were you doing at 8 a.m. Hawaii time?

We haven't had a place to preserve your stories until now. The Library of Congress has initiated the Veterans History Project, co-sponsored by AARP. Join veterans of WWI, WWII, Korea, Vietnam, and the Persian Gulf War with your stories.
