#### Fund Raising Effort –Your Support Needed!

We asked in previous newsletters for one or more members to step forward and lead fund-raising efforts for your Post 209. No one has answered that call as of this date.

On average, approximately \$1,200.00 per month is spent for on going Post 209 office and American Legion programs expenses. We are drawing down our savings to pay these expenses. The need to generate income is necessary and real.

Yes, we certainly understand that many members find it difficult to get out for one reason or another, and others are pressed for time to work in fund raising activities. Regardless, the need for income won't go away.

There is a way to get around this dilemma, but it will need the full support of all members.

The proposal is for all members who have the means to donate \$10.00/month or \$120.00/year to your Post 209. Post 209 is a 501c(19) organization for tax purposes and donations are deductible on your tax returns.

Please understand that I am not giving tax advice. Check with your attorney or tax advisor for tax advice. Think about it, if members donated \$10.00/month or \$120.00/year to Post 209, it will help solve the need for other fund raising activities and asking members constantly to give of their time and for them to work in other fund raising efforts. In recognition for those that give, an appropriate certificate will be designed and presented to

members that donate and support this new effort to raise funds.

Your Executive Committee needs to hear from you and to learn from you as to how you perceive this proposal.

### **From Adjutant - Ann Foster**

The Commander's comments re fund raising apply to more than paying the monthly bills. We do not get to keep enough of your dues at this level to pay for the minimum needs.

However, the more who do pay to belong to the Post their dues go towards easing the burden. Additionally, if those who are able to give \$10.00 a month or \$120.00 a year, towards our monthly bills we would then be able to manage until we are able to get a Post home.

You may ask how we will raise money after that time and we have an answer that should be good for all of us. When we are able to get a Post home, we will be able to rent the hall portion to those who still call us looking for a place to have a wedding reception, an office party, a group business meeting,

etc. This will put income back into our coffers, but without the effort of previous fund raising events. We are well aware that many of our current members are not able to do some of the things we have done before for providing the monies we should have for Legion programs. But, we can overcome that by having a Post home with a hall that we can rent out.

Thus, I ask you, along with the Commander, to seriously consider responding to the suggestion to contribute some extra amount of money towards our needs at this time.

We now have 261 members towards our goal of 285 for 2004. That means we need ten more for 95% and 24 more for 100%. We have not been this far along for quite some time. Please consider

It takes weeks for their personnel effects to catch up with them.

- telephone cards of at least 30 minutes
- rolling luggage (small), totes, carry-ons
- individually wrapped snacks
- magazines
- notepads, pens
- playing cards and games
- sweat pants and shirts (all sizes)
