

#### LIFE PLAN INCREASES BENEFITS DURING 1987

Indianapolis (ALNS) - A 15 percent "across-the-board" increase in death benefits paid in 1987 has been approved for the American Legion Life Insurance Plan, Jerome P. Dobel, Jr., Chairman of the Legions Life Insurance and Trust Committee, has announced.

Chairman Dobel pointed out the approval of the added benefits by the Legion's National Executive Committee marks the 18th time since the inception of the Life Insurance Plan in 1958 that an increase in the annual amount of protection offered by the Program has been granted. The increase in benefits comes at no increase in premium.

Also, effective January 1, 1987, the present maximum coverage of 12 units will be increased to fourteen (14) units. A unit of life insurance is the amount of coverage available according to the applicant's age.

The basic insurance rates remain unchanged from those introduced at the Plan's inception in 1958.

#### VETS PROGRAMS SCORE GAINS AGAINST GROWING DEMANDS FOR FEDERAL SPENDING CUTS

Washington (ALNS) - With the recently adjourned 99th Congress tackling issues ranging from fiscal problems to immigration reform, victories for Veterans were not insignificant, especially considering the Budgetary constraints mandated by the Gramm-Rudman-Hollings deficit reduction package. Efforts by the American Legion were instrumental in exempting programs for Veterans from automatic cuts called for by the Budget Savings Act.

Veterans and dependents who receive pensions and disability compensation payments from the Veterans Administration received a 1.5 percent increase beginning December 1. The omnibus Veterans Health Care Bill also includes provisions to expand medical care to former prisoners of war and exempts more programs from mandatory Gramm-Rudman Budget cuts. Chronically ill Veterans may now be provided with respite care by the VA, and Veterans who were exposed to ionizing radiation will be entered into a National Registry.

#### VET CENTERS RETAINED

The VA Readjustment Counseling Program for Vietnam Veterans (Vet Centers) has been extended for one year in its present form. This provision prohibits the VA from integrating most Vet Centers into traditional VA medical facilities next year.

The VA will also take a close look at the increasing number of defaults on VA-guaranteed home loans and try to come up with ways to help prevent Veterans from buying homes they cannot afford.

In April, President Reagan signed legislation which radically changes the way the VA delivers care to Veterans in its medical facilities. Non-service connected disabled Veterans will have to prove that they are poor enough to receive VA health care. The legislation also allows the VA to be reimbursed from a Veterans Health Insurance Company. The American Legion stood alone among the Veteran's groups in opposing these changes and have vowed to monitor the implementation of these new guide lines to make sure Veterans receive the care they deserve.

On the positive side, Legislation calling for the judicial review of V.A. claim decisions failed during the last Congress. The Legion has long maintained that the current system of claims adjudication is fair and non adversarial for Veterans seeking assistance. However, the Legion recognizes that this matter will come up again in the next session of Congress.

#### VA HOME LOAN PROGRAM

Twice during 1986, the VA Home Loan Program faced fiscal crisis which threatened to shut down the whole program. In March and again in May, President Reagan approved legislation which expanded the VA's lending authority to allow the Program to continue.

#### JOB BOOST CONTINUED

Also in economics news, the Targeted Job Tax Credit which provides tax incentives to employers for hiring Veterans was reauthorized, a measure to extend the placement of Vietnam-Era and handicapped Veteran's in the Federal work place was approved, and Legislation was passed which prohibits hiring discrimination against National Guard members and members of the Reserve.

## NEW CONGRESS IN JANUARY

A new and vastly altered Congress will convene in January with Democrats holding majorities in each house of the National Legislature. The American Legion's National Legislative Commission will keep alert to future possible changes in Veteran's programs as the 100th Congress convenes in January.

The area of health care for aging Veterans, SDI, general defense and Veteran's economics programs will be of primary interest as Committee Chairman change in the Democratic controlled Senate.

## '86 CONVENTION URGES POW/MIA SOLUTION

During the 1986 National Convention in Cincinnati, delegates expressed the American Legion's deep and continuing concern on the POW/MIA issue. These Legionnaires were concerned that 33 years after the Korean Truce more than 8,000 Americans are still missing and 13 years after the Paris Peace Treaty more than 2,400 Americans are still unaccounted for in Southeast Asia.

Through their unanimous approval of four resolutions, the Delegates expressed the Legion's total commitment to a speedy and complete solution to the POW/MIA problem.
