A MEMO TO ALL LEGIONNAIRES FROM BRUCE THIESEN, NATIONAL COMMANDER

SUBJECT: CALL TO ACTION ON POW/MIA ISSUE

The American Legion has taken a leadership role in the complex struggle to liberate or account for American POW/MIAs from Vietnam, Korea, the Cold War and World War II. Today, we face a major crisis calling for immediate action by millions of Legionnaires.

Press articles and other indicators point toward the likelihood that President Clinton will soon, after consulting with the Congress, end the U.S. economic embargo against President Clinton has Vietnam. repeatedly stated that the embargo would remain in effect until Hanoi increases significantly fullest the cooperation, and possible accounting of POWs and MIAs has been accomplished. However, it now appears that a small group of advisors will recommend the embargo be lifted since they believe Hanoi is truly cooperating.

If the economic embargo is lifted, the United States will have no leverage left to compel meaningful cooperation in resolving the POW/MIA issue by Vietnam. We urge you to all stops and out the many immediately mobilize as Legionnaires as possible to write to President Clinton and their Senators and Representatives.

The essential mesage should be:

- keep faith with American To POW/MIAs and their families, do not embargo until the fullest possible the provides which is defined as accounting, prisoners. over live turning repatriating remains of those who were killed in action or died in captivity, or providing a valid conclusive report why neither is possible.
- The embargo is the only "stick" available to the U.S. Government to compel Hanoi's long overdue POW/MIA cooperation.
- Increasing amounts of credible evidence continue to surface that Vietnam and Laos did not return all American POW/MIAs during Operation Homecoming in 1973.
- Documents obtained from Russia substantiate that Vietnam held hundreds more American POWs than Hanoi ever publicly acknowledged.
- It is important that The American Legion and other veterans act now to let Washington know "Grassroots Americans" and "Blue Cap" Leionnaires demand the President and Congress keep faith with the POWs and MIAs, their families and members of the active military services.
