Response To Prayers

Note: This is a follow on response to a Letter to the Editor from last month's Centennial Newsletter regarding why a Chaplain at a Post event invoked the name of Jesus in his prayer.

As your Department Chaplain, I have been asked this question a lot. At the National Chaplain's conference, we have discussed this issue over and over in the three years I have attended this Conference. The outcome is always the same, it's up to the individual that is saying the prayer. For many of us ordained ministers, it's very hard not to say the name of Jesus Christ. I myself try to not do it, but I do slip up and say it on occasions.

The perception that as Christians we do not care of the other religions is totally wrong. As Chaplains, we do care about all religions, and we are trying to be sensitive to the situation. We know there are many other religions besides the Protestant religion. I myself was raised in the Buddhist religion until I converted to Christianity at a very late age. I recall when I told my mother that I was a Christian, she told me, "we all pray to one GOD and it is just that we do it in different ways, it is not wrong to pray the way we want to. Just respect the other person's way of praying."

Keep in mind that as a Chaplain it is very hard to keep all of the different religions in place and it's very hard to satisfy all of them. On December 16th, 2017, members of American Legion Neal Thomas Jr. Centennial Post 209 were very much at the forefront of honoring our departed Veterans with the Wreaths Across America event.

Each year, on the third Saturday in December, the graves of departed Veterans nationwide are decorated with live wreaths for the Christmas season. The event happens simultaneously across all time zones in the U.S.A. In the Pikes Peak region, ceremonies began at 10:am. This year, thousands of wreaths were placed at Memorial Gardens Funeral Home and Cemetery in Colorado Springs, the Air Force Academy cemetery, and Imperial Memorial Gardens cemetery in Pueblo. The wreaths were purchased from Wreaths Across America, with a deadline ending in late November to allow time for delivery to the cemetery.

In the chapel at Memorial Gardens in Colorado Springs, the Post 209 Honor Guard posted the Colors of the United States, along with the service flags from each branch of the military and the POW/MIA flag. This was followed by a keynote address by the Adjutant of the American Legion Department of Colorado, Mr. Charles "Pat" Smith. After Mr. Smith's remarks, uniformed past and present members of each service branch conducted the solemn "Laying of the Service Wreaths".

From the Historian - January

The city of New Orleans, a crescent at the mouth of the mighty Mississippi is known today for Mardi Gras and jazz. But In the winter of 1815, the British saw it as the key to victory against the Americans and the War of 1812. Own New Orleans and you control access to the Mississippi and the newly purchased American lands to west. Spurred on by previous victories at Baltimore and Plattsburgh, the Redcoats began their attack on New Orleans on December 12th with the Battle of Lake Borgne.

Lake Borgne lies just southeast of Lake Pontchartrain, and on that morning some 1200 British sailors were tasked with clearing out the American ships blocking access to the lakes. The Brits attacked in 42 longboats and quickly defeated the Americans, thus freeing the lakes for the invasion force.

By December 23rd, the British army has reached the eastern bank of the Mississippi. New Orleans was now easy pickings.....but in one of those fateful moments that changes history, the British commander John Keane instead of attacking chose to encamp and wait for further troop to arrive. Unfortunately, this period allowed Major General Andrew Jackson to become aware of the British positions. Jackson attacked the Englishmen and then retreated to Rodriguez canal.

While the battle itself could hardly be called a victory, it did give the British pause and they continued to wait for further reinforcements, and it would prove to be their undoing.

While the British waited, Jackson got to work. First, he declared Martial Law in the city and effectively enlisted every able bodied man whether they be military, citizen, slave, or pirate. "Old Hickory" ordered the Rodreguez to be widened and earthworks built. Upon these earthworks Jackson had 8 batteries of artillery placed and thus Rodreguez Canal became "Line Jackson".

On the morning of January 1st the British began a relentless bombardment of the earthworks. The British were nearing success when they ran out of ammunition with many Americans abandoning their positions. Once again the British hesitated and once again it would cost them.

Finally, on January 8th under the leadership of Lieutenant General Edward Pakenham, the English launched a two pronged attack. The first attack led by Colonel Robert Rennie was to attack across the Mississippi, however shortly after the attack began he was mowed down and the British troops were quickly routed and picked off as they fled the battle.

Unfortunately for the British, Pakenham wasn't having any better luck with the main force attacking Line Jackson. Counting on the prevalent fog in the area his troops began their approach on the redoubts. But with the rising sun the fog lifted leaving the Americans with unobstructed views of the advancing troops. Reinforcements for the English were delayed when boats became trapped in the mud of the Mississippi.

In the end, some 4,732 Americans successfully defended the City of New Orleans against a British force of 14,450. The final major battle of the War of 1812 was a decidedly lopsided victory for the Americans with 333 casualties compared to the English 2459. The Battle would immortalize Andrew Jackson and he would go on to become the 7th President.

It would have been interesting to see how history would have played out had the British been victorious. Would anything have really changed? For unbeknownst to both sides, they technically were not at war! The Americans and British had already made peace with the signing of the Treaty of Trent back on December 24th.

And that is history!

Tri-Care Update

TRICARE Enrollments Shifting from Fiscal to Calendar Year Starting in January 2018

The following information comes from TRICARE. Please be aware that this information does NOT apply to those using **TRICARE For Life.**

Starting January 1, 2018, Cost changes for TRICARE Benefits transition from a fiscal year (Oct. 1 – Sept. 30) to a calendar year calendar year (Jan. 1 – Dec. 31) makes the TRICARE benefit consistent with civilian health plans. The change will largely affect those plans which have an enrollment fee and are currently billed by the fiscal year. This includes retirees and their family members in TRICARE Prime, TRICARE Retired Reserve, TRICARE Reserve Select and those in TRICARE Young Adult plans. This change is one of several **TRICARE** is changing. Here is what you need to know:

Enrollment fees apply to retirees and their family members enrolled in TRICARE Prime, those enrolled in the premium-based plans, and several others, including:

TRICARE Young Adult – Prime Options TRICARE Young Adult – Standard Options
TRICARE Retired Reserve TRICARE Reserve Select Continued Health Care Benefit Program
(this will continue to follow a fiscal year cycle) US Family Health Plan

If you're in a plan now that requires enrollment fees, there will be a transition period, from Oct. 1, 2017, to Dec. 31, 2017, so you won't experience additional costs in 2017. During this time, you'll continue to pay your enrollment fees. However, enrollment fees will be prorated for the three-month period and billed accordingly for enrollees who pay on a monthly or quarterly basis. If you pay enrollment fees on an annual basis, you'll be billed for the fees to cover the three-month period and sent a billing notice for the annual fee for calendar year 2018.

TRICARE will extend payments (For example, Catastrophic caps and deductibles) that usually reset on Oct. 1 through the end of the calendar year. Any enrollment fees you pay during the transition period will continue to count against the catastrophic cap until it resets on Jan. 1, 2018. This means that if you reach your fiscal year 2017 catastrophic cap, you will not have additional out-of-pocket. Costs for authorized TRICARE-Covered Services for the last three months of the year. On Jan. 1,2018 new rules for deductibles and catastrophic caps will apply to some costs.

This is your benefit. Here is what you need to do:

If you pay your enrollment fees by allotment, you don't need to do anything. You will continue to pay your enrollment fees automatically. Unless you cancel your allotment, TRICARE will continue to deduct enrollment fees starting Jan. 1 2018. If you pay enrollment fees by electronic funds transfer (for example, debit card, credit card and electronic check) and are in an area where a new regional contractor will be delivering services, you will need to update your payment method with your new regional contractor in December.

If we have advance notice of the need for funds, a Veteran can apply to Department, thru us, for help from their Veterans Fund, Childrens' Fund, or Temporary Financial Assistance. Approval of these requests can take one to two weeks. However, there are times when the Veteran has an immediate need. That's where the Post Veteran's Fund comes in. A tank of gas, a gift card from King Soopers, or two or three nights in a motel to bridge the time before permanent housing starts or a VA check comes in. This is not blowing our own horn, just want to let you know what we do with the donations the Post 209 men and women generously give. Thanks to you from us and those Veterans in need.

Bringing a Little South to the West

In some of my previous articles, I made references to the house where I grew up, but I never really shared with you about my neighborhood and details of my home of 18 years. To help you better understand me (Jackie would tell you that's not possible, she's been trying to understand me for almost 50 years), you need to know about where and how I grew up. I believe in many ways, who we are is often reflected in the environment in which our young lives were shaped.

I was born in April, 1953, in Wynne, Arkansas. The fact that it was the first day of the month has no relevance. My parents moved to the Memphis, TN suburb of Oakhaven in June that same year and bought a small 3-bedroom ranch style home with one bath on a corner lot. At the time they bought the house, I had a brother 1 year older than me and a sister 6 years older. About 17 months after I was born, Mom and Dad brought home my little sister.

A family of 6 living in a one bath house was pretty normal for the day. Today, I doubt you can find a new 3-bedroom house with only one bath. We didn't have a shower, just a bath tub. As we grew older, the logistics of scheduling bath time was pretty complicated, but Mom always seemed to make it work.

The Oakhaven district, as it was later called, was initially an unincorporated area. Not too long after Mom and Dad bought the house, the city of Memphis added it to their tax base. The main street we lived on bordered the Memphis airport on the east side. As the airport grew, the planes got closer and closer to the house, but never to the point where we were forced to move (until 36 years later). However, we were close enough to the air traffic that we kept a crack in the small dining area ceiling that stretched from the corner of the room to the light in the middle of the room. And whenever out of town family and friends spent the night with us, they were kept awake all night by the planes taking off and landing. Because we were so accustomed to the noise, we slept right through it. I guess that's one of the reason we didn't many overnight guests.

There was a huge field directly across the street that was owned by the airport. It had a gated asphalt driveway that led to a maintenance shop about 300 yards from the street. But the open field from the street to the maintenance area was our playground. Many football and baseball games were played in that field. The maintenance guys left us alone because we never made an attempt to get close to the maintenance buildings. They weren't using the field and didn't mind us using it. That was before the world became litigious. That could never happen today; too much liability for the airport.

Slowly but surely, "progress" made its way to our neighborhood. The airport continued to grow and more room was needed for more maintenance buildings. I had already left to join the Army when the city exercised the right they had been given by the 5th amendment of our US Constitution and declared "eminent domain" on our world. All the neighbors were notified that their property was needed and staying was not an option. They were allowed to contact the city and get a "fair market price" for their house. When/If they sold, their house was razed and what was once suburban lawns became open fields.

Dad watched as all his neighbors left one by one. He refused to sell or contact the city. As a result, his and Mom's house was the last of about 200 homes to be taken over. Between the time our neighbors left and Mom and Dad were forced out of their home, we took advantage of the open space. Dad had three 4-wheelers and we made good use of what was once a suburb and now a motocross field that stretched for 2 or more miles.

Then one day there was a knock on Dad's door. It was a reporter from one of the local TV stations. He asked what Mom and Dad were doing still living there. Dad explained he raised 4 kids and three dogs at this home and wasn't in any hurry to leave. The reporter told him that according to the city drawings he had, this was a vacant lot. Dad assured him it was definitely not vacant. He told the reporter that not only did they still live there, so did the ghosts of four young kids and three collie dogs. But eventually, they forced Mom and Dad out. While they were given a very fair price for their home and the city picked up the cost to move them, it broke Mom's and Dad's heart to leave. Even though I hadn't lived in that house for almost 20 years, it affected me as well. I still have dreams about the neighborhood and the house.

I have been VERY blessed to live the life I have lived up to this point. My Army career (and since) have taken me many places and to different parts of the country and world. But for me, there will always be two homes; the one I share with my bride of 46 years, and little 3-bedroom one bath home my parents occupied for 36 years in the suburb of Oakhaven in Memphis.
