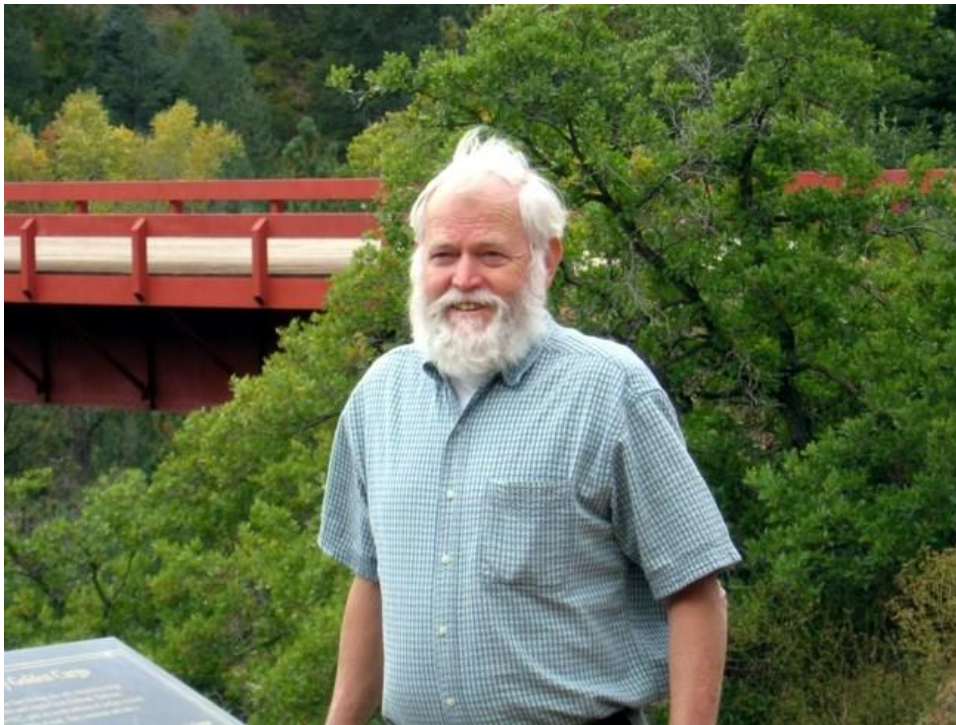
If restrictions are further reduced or changed in any way, we will adjust as appropriate. We recommend you continue to monitor our website and Facebook page for updates.

## IN MEMORY



Charles J. "Chuck" Zeitvogel was transferred to Post Everlasting when he passed away at home on 22 January, 2021 of "natural causes." Chuck was born in Rochester, New York on September 4, 1935 and grew up on a farm near Byron with four siblings. While still in high school, he enlisted in the Army National Guard. At the age of 20, he joined the United States Air Force and traveled the world for 30 years retiring as a Chief Master Sergeant.

After retirement, Chuck continued to serve his church and community as an active leader in Boy Scouts, The American Legion Post 209, The Knights of Columbus, and The Retired Enlisted Association. He was a 33-year member of The American Legion and served Post 209 in many capacities and positions. Chuck served as Post 209 Commander from 2001-2004 and continued serving after his terms of Commander ended. He remained a very active volunteer throughout his life and provided guidance and counsel to all Post Commanders who followed him.

Chuck gave back to the people around him by volunteering to help do taxes for the VITA program and the AARP. He entertained and educated young people as a docent at the Cheyenne Mountain Zoo and engaged all ages through Toastmasters. He was a member St Patrick's Catholic Church for over 30 years and served there as in various capacities.

A lifelong learner, he received an Associate Degree in Applied Science, Food Technology in 1955 from State University of New York at Morrisville. Chuck then obtained his Bachelor of Art degree in Business Administration from Wittenberg University OH in 1975, and finally his Master of Science in Public Administration from the University of Colorado, Colorado Springs in 1991.

He was a thoughtful husband, wonderful father, and beloved grandparent. He leaves behind his wife Veronica; son Chris; daughter Marla, her husband Marty and their three children Derek, Callista, and Phoebe; daughter Lisa, her husband Mike and their four children Corrie, Katie, Gregory, and Elizabeth. He also leaves his brother Bill and sister Mary, as well as stepchildren and grandchildren.

## **FROM THE DESK & MIND OF THE COMMANDER**

Volunteers are the backbone of the American Legion; without them we wouldn't be able to support the thousands of Veterans we do each year. From Post Commander to donating time or a pair of socks every volunteer plays their part in continuing the mission of the American Legion. There are plenty of reasons to get involved, but the number one reason is happiness.

A study published recently in the Journal of Happiness Studies, researchers examined data from nearly 70,000 participants in the United Kingdom, who took surveys about their volunteering habits and mental health, including their distress and functioning in everyday life, every two years from 1996 to 2014.

Compared to people who didn't volunteer, people who had volunteered in the past year were more satisfied with their lives and rated their overall health as better. Additionally, researchers found that people who volunteered more frequently experienced greater benefits: Those who volunteered at least once a month reported better mental health than participants who volunteered infrequently or not at all.

According to Ricky Lawton, associate director at Simetrica Research Consultancy, lead author of the paper, a combination of factors is likely at play. First, volunteering appears to be intrinsically rewarding when we help others. Second, volunteering is likely to help boost our sense of social connection. In particular, for older adults, volunteering can be a way to stay connected to others after retirement.

Finally, volunteering can be a way to build professional skills and try out leadership opportunities, which is especially relevant to younger Veterans. In the study, researchers found that participants ages 16-24 and 55-74 were especially likely to benefit from volunteering, perhaps because of the opportunity to build social connections and new skills.

So maybe volunteering can do more than just help others; maybe it can help your own wellbeing. There are plenty of opportunities in the Post, finding one is as simple as reaching out or coming to a Friday night dinner. Together we can continue to serve the Veterans and their families in this community.

## **FROM THE DESK OF THE JR. VICE COMMANDER**

Excerpts from February's speaker, Don Miranda:

Death can be one of the hardest things to go through, it is ok to not be ok. You will experience a range of emotions from denial to happiness, sometimes all at once. You can never replace those that are lost, but you can replace income. No one likes to plan for these eventualities as it is an uncomfortable conversation.

Things to consider:

1. Insurance - Accidental Death, Whole vs. Term Life and Long Term disability.
2. Estate Planning - Most people do not have a Will or Trust. Consider purchasing software for ~\$75 to assist in paperwork preparation in the proper format for your state. All you have to do

then is print and get notarized at a bank. Will are subject to being thrown into and stuck in Probate, Trusts are not.

3. Burial plans - Arrange for a plot, decide on what military honors you would like to have, which funeral home and set aside enough money to cover the casket and delivery services.
4. Ensure you have multiple copies of your DD214 and your loved ones know where it is.
5. Take care of your survivors - make sure they understand your VA benefits of survivorship and have multiple copies of your Death Certificate to initiate a claim.
6. Death Certificates can be very non-descript. It will be a generic Manner and Cause of death. It is important to capture contributing factors that are in the vet's VA records so that you can tie back a death to an underlying condition (if applicable).
7. Make sure your survivor and/or trustee knows your medications, co-morbidities, medical conditions, service connected issues, VA contact # for Regional Office of Veterans Benefits Association.

## Sea to Shining Sea

### Mosby's Story:

The message and goal are unity. Just the American flag and a handful of Americans. I started this over coffee and a sunrise on my back porch. America the Beautiful was stuck in my head that morning. It was the week before elections. Monday AM to be exact. I was angry at my local media for only showing stories of violence being planned for the upcoming election. A false narrative laced with lies and propaganda. And golly gee, they didn't even mention [other] groups. And I was angry. Anyway, I turned off the news and walked out on the deck for a beautiful sunrise and started singing... "Oh beautiful for spacious skies..." Then I thought...

What could we do to defeat the media narrative, and cancel out all this negative with something positive? And I was stuck on "from sea to shining sea." So, I started making phone calls.

By Wednesday AM I had most of it set up. Just complete strangers who really don't even know each other in real life. A simple show of unity, from sea to shining sea.

The idea, and goal is just to pass the flag as far as we can. To highlight America the Beautiful, and shift some of the focus off the negative. To show that even in the most trying times, America is still a beautiful place, with beautiful people, from sea to shining sea...

And so, it began that Sunday. The flag left Johnny Mercers fishing pier in Wrightsville Beach, NC at 0900 hrs. on Nov 1st.

And so began its journey. And so began the unity, that you see before you, for the simple idea of passing a flag, from sea to shining sea, and uniting everyone involved, and even some who aren't. So, in the end we hope to display it in a museum here in America and know it succeeded in uniting a small handful of beautiful Americans, from sea to shining sea.

And that's it. No fancy speeches... no gimmicky slogans, just America the Beautiful, from sea to shining sea. No motives, no politics, no anything. Just one brain fart, a cup of coffee, and someone who tries to do some good in the world from time to time.

So far, everyone I invited in has a story of unity. A unique story for everyone. From being stranded hundreds of miles from home with a load of supplies, to countless hours of community service, to many sleepless nights organizing disaster assistance. Everyone has a special place in this story. And everyone has their own story. It's those stories that make the endeavor so incredible. The focus started with unity. And what better place to start than with those I knew who united hundreds of thousands of Americans in times of dire need. And each story starts with... I did it because I could.

So, I passed a flag across the country, because I knew we could.

### Sandra's Story:

The flag that Mosby started at the beaches of North Carolina was semi-retired on the western border of N. Carolina and will be sent back to him by a VFW Veteran. The second flag traveled from the border of North Carolina to Colorado Springs, CO where Sandra Seidell and Tom Bruner received the flag. The flag had frayed quite badly during its travels from the Chattanooga Choo Choo Hotel in Tennessee down into some of the hardest hit hurricane areas of Alabama,

Louisiana, and Texas. It needed to be retired and replaced with a new flag purchased by Sandra at Affordable Flags and Fireworks with funds from Rachel Carre (TX Volunteer Driver).

Sandra reached out to a dear friend, Tim Keck, from the local VFW Post 101 in Colo Sprg's for help. Tim quickly organized the Honor Guard ceremony with the American Legion Post 209 today to semi-retire the second flag. Present were Michael Wescott (Honor Guard Captain and member of American Legion Post 209), Jeraud Stuart (Honor Guard member and member of American Legion Post 209), Brian Wess (member of El Paso County Homeless Veterans Coalition), Tom Bruner (CO Volunteer Driver for Sea to Shining Sea Project), and Sandra Seidell (CO Volunteer Driver and U.S. Army Veteran).

The third flag will travel to the California beaches before being semi-retired. All three flags will be shipped back to North Carolina with the logbook and all the photo ops taken along the way. The little green logbook that accompanied the flags across America has entries within for every leg of the trip. Each entry lists every person who handed the flag off from American to American and the route where the flag visited across America. Photos will be printed, and video will be presented to a museum with the hopes of displaying unity in America against all odds. Best Regards,

## **FROM OUR SERGEANT-AT-ARMS**

While there are some limitations to be observed, 2021 sees American Legion Post 209 moving forward in the new year. We are seeing members, old and new alike, returning to the Post for dinners and meetings. The implementation of a hybrid General Membership Meeting provides the ability for any Post 209 member to participate without being concerned with potentially being exposed to COVID-19. The hybrid implementation does add some complexity, though we will all be able to adjust and work through it.

As the Post 209 Sergeant-At-Arms, a primary duty is the maintaining of order during all Post 209 activities. With the resumption of activities at Post 209, I want to take a moment to provide a little guidance to be followed/observed during our General Membership Meeting. After reviewing The American Legion 2020 Officer's Guide and Manual of Ceremonies, I believe that Section 2 contains some information that members of the Post, old and new alike, should be aware of during the General Membership Meeting. From my own experience, when I became a member in July 2019, this is information that would have been very helpful to know. Section 2 *Manual of Ceremonies* was adopted by The American Legion in 1921 and the first four items have been copied from this section as very important guidelines for Post 209 members to follow.

1. The ceremonial services of The American Legion must be conducted with the solemnity befitting the dignity of this organization.
2. No one shall be admitted during the opening, initiation or closing ceremonies of a meeting.
3. A member entering the hall after the meeting has begun shall advance to the center of the room, salute the colors and be seated.
4. Any member desiring to be excused from the hall while the meeting is in progress – except during a prayer, the obligation or period of silence – shall advance to the center of the room, salute the colors and leave.

The Sergeant-At-Arms is positioned at the door to facilitate an orderly entry/exit from the room once the meeting has started. If a member starts to enter during the activities identified in 2. above, he/she should stop, close the door, and wait until the door opens for them when the activity is concluded. For situations identifying with 3. and 4. above, saluting the colors from the end of the ramp and railing leading to/from the door is considered acceptable.

Another item that members need to be mindful of when attending the General Membership Meeting is that cell phones need to have their ringers off by either placing the phone on vibrate or turning it off. If a member has the need to make or take a phone call (alerted by the vibrating phone), they can follow 4. above in order to leave the room to make/take the call, then follow 3. above when they are finished. Phones are not to be answered until the member has exited

the room as this creates a disruption to the meeting and breach of respect for the person who is currently speaking.

I look forward to seeing as many members as possible at the Post during the next General Membership Meeting, or online if the situation warrants a member needs to attend virtually.

## FROM OUR POST SERVICE OFFICER

Currently, I have reached out with assistance to 68 Veterans for the calendar year 2020 and 12 for 2021. You may not be aware, but we have a Post Veterans' Assistance Fund that was first established by our Post's namesake, Neal Thomas, Jr. As of 31 January, we have just over \$5,532 in emergency funds. That may sound like a lot of money, but it goes very quickly when used to assist Veterans for emergency support.

If you would like to donate to keep this fund going, you can mail us a check or go to our Post website at [legion209.org](http://legion209.org) and click on the "Donate" button. You can enter the term PVAFF to ensure the donation is earmarked for this special account. Remember, we are a non-profit charity so your donation may be tax deductible. Check with your tax advisor to find out!

### **NPRC Veterans Service Officer (VSO)- Record Corrections Correcting Clerical Mistakes**

A clerical error made on a DD Form 214 (or predecessor form) at the time of the creation of the document may be corrected by NPRC, **if evidence is found in the record or, in limited cases, if satisfactory evidence is provided. Retroactive service type awards may also be corrected based on information contained in the record.** A correction is usually made by issuing DD Form 215, not by issuing a new DD Form 214 (there are exceptions).

EXAMPLES OF ITEMS NPRC MAY CORRECT USING DD FORM 215:

- Misspelled name;
- Wrong initial(s);
- Reversed first and middle name;
- Reversed first and last name;

- Nickname cited rather than full legal name;
- Name change (if not changed after separation);
- Incorrect date of birth;
- Transposed digits of social security number or service number; and
- Information regarding medals.

#### Responsibility of Military Service Department

NPRC, as the physical custodian (but not the legal custodian) of military records, **is not authorized to amend** them. Amending a military record (changing substantive information) is the responsibility of the military service department creating the record.

EXAMPLES OF ITEMS THAT NPRC IS **NOT** AUTHORIZED TO CORRECT USING DD FORM 215, CORRECTION TO DD FORM 214, CERTIFICATE OF RELEASE OR DISCHARGE FROM ACTIVE DUTY:

- Character of service;
- Reason for separation;
- Separation authority;
- Separation code;
- Narrative reason for discharge;
- Dates of time lost;
- Reenlistment code;
- Time-in-service;
- Social security number if it differs from the one shown in the military record by other than transposed digits;
- Significant name changes if it differs from the one shown in the military record;
- Any correction that is not clearly documented in the record; and
- Any correction that may be controversial in nature.

**NOTE:** This information does not usually apply to “Archival” records. (A record becomes “archival” 62 years after discharge, retirement, or death in service.)

A veteran's DD 214 is a very important document for life after the military and any error(s) on it can lead to adverse effects in trying to seek future employment, Veterans Administration disability and compensation benefits. With the DD 214 being your Report of Separation, it lists such information as military education, military training and perhaps most importantly, it lists your separation information. Any mistake on your DD 214 can and should be corrected as soon as you find it by using a Form DD 149.

If you do not have access to a computer or if you need help in completing the DD 149, your local VA office will be able to give you a copy.

Fill out and complete all sections of the DD 149. Provide the best detail that you can as to why you believe there is an error(s) on your DD 214 and include any supporting documentation when mailing in your DD 149.

Mail your completed DD 149 to the appropriate mailing address which is based on which branch of the military you served in. Addresses for each of the branches of the military are listed on page 2 of the DD 149.

## INSTRUCTIONS

Under Title 10 United States Code Section 1552, Active Duty and Reserve Component Service members, Coast Guard, former Service members, their lawful or legal representatives, spouses of former Service members on issues of Survivor Benefit Program (SBP) benefits, and civilian employees with respect to military records other than those related to civilian employment, who feel that they have suffered an injustice as a result of error or injustice in military records may apply to their respective Boards for Correction of Military Records (BCMR) for a correction of their military records. These Boards are the highest level appellate review authority in the military. The information collected is needed to provide the Boards the basic data needed to process and act on the request.

1. All information should be typed or printed. Complete all applicable items. If the item is not applicable, enter "None."
2. If space is insufficient on the front of the form, use the "Remarks" box below for additional information or attach an additional sheet.
3. List all attachments and enclosures in item 9. Do not send original documents. Send clear, legible copies. Send copies of military documents and orders related to your request, if you have them available. Do not assume that they are all in your military record.
4. The applicant must exhaust all administrative remedies, such as corrective procedures and appeals provided in regulations, before applying to the Board of Corrections.
5. ITEM 5. State the specific correction of record desired. If possible, identify exactly what document or information in your record you believe to be erroneous or unjust and indicate what correction you want made to the document or information.
6. ITEM 6. In order to justify correction of a military record, it is necessary for you to show to the satisfaction of the Board by the evidence that you supply, or it must otherwise satisfactorily appear in the record, that the alleged entry or omission in the record was in error or unjust. Evidence, in addition to documents, may include affidavits or signed testimony of witnesses, executed under oath, and a brief of arguments supporting the application. All evidence not already included in your record must be submitted by you. The responsibility of securing evidence rests with you.
7. ITEM 8. U.S. Code, Title 10, Section 1552b, provides that no correction may be made unless a request is made within three years after the discovery of the error or injustice, but that the Board may excuse failure to file within three years after discovery if it finds it to be in the interest of justice.
8. ITEM 10. Personal appearance before the Board by you and your witnesses or representation by counsel is not required to ensure full and impartial consideration of your application. If the Board determines that a personal appearance is warranted and grants approval, appearance and representation are permitted before the Board at no expense to the government.
9. ITEM 11. Various veterans and service organizations furnish counsel without charge. These organizations prefer that arrangements for representation be made through local posts or chapters.
10. ITEM 12. The person whose record correction is being requested must sign the application. If that person is deceased or incompetent to sign, the application may be signed by a spouse, widow, widower, next of kin (son, daughter, mother, father, brother, or sister), or a legal representative that has been given power of attorney. Other persons may be



authorized to sign for the applicant. Proof of death, incompetency, or power of attorney must accompany the application. Former spouses may apply in cases of Survivor Benefit Plan (SBP) issues.

### Buy A Brick Fundraiser!

We are re-introducing an exciting fundraiser for our Post. We are partnering with Polar Engraving to offer our members, family, friends, and our corporate Veteran-friendly supporters an opportunity to purchase an engraved brick to adorn our landscaping project we are working. The engraving uses the same technology as used on tombstones so it's extremely durable. Here are some FAQs:



- **What Are We Having?** A Brick Fundraising Event
- **Why?** To Further Funding of our American Legion Programs
- **What Size Are the Bricks?** 4"x 8" or 8"x 8" bricks for individuals, and 8"x 8" or 12"x 12" bricks for our corporate supporters.
- **What are the Costs for the Individual Bricks?** Prices vary depending on size, style and lettering desired, but typically range from \$75 to \$200. For the 8x8 or 12x12 bricks, you can add a second emblem. Contact the Adjutant for ordering details. There is **NO** additional cost for the second emblem on the larger bricks.
- **What are the Costs for the Corporate/Veteran Supporter Bricks?** Again, prices vary depending on size, style, and lettering but typically range from \$125 to \$500.
- **What is the Difference between Individual and Corporate Bricks?** Individual bricks are identified for Veterans, and family members of Veterans wishing to purchase a brick to honor their Veteran. The corporate bricks are for our Veteran-friendly supporters and businesses who wish to show their continued support to our Nation's heroes by purchasing a brick.
- **Is the Brick Purchase Restricted to Members of the Post 209 Family?** No. We encourage members to buy a brick for themselves as a lasting memory of their association with Post 209. We also welcome anyone to purchase a brick for their Veteran loved one, or to show their support to our Veterans.
- **Can I Buy a 12"x 12" Brick for Myself/Loved One?** Absolutely!
- **Where Do I Go to Buy a Brick?** We have a link on our website. Just visit [legion209.org](http://legion209.org) and click on "Walk of Honor." Or, you can visit <http://polarengraving.com/ALPost209> to buy your brick. The site is very user-friendly and will walk you through the design and purchase. You will be able to see a preview of your brick before finalizing the purchase.
- **How Do I Pay For the Brick?** We have the site setup to accept payment via PayPal or by check. PayPal is an extremely safe way to purchase a brick and you don't need a PayPal account to use it.
- **Where Will the Brick Be Shipped?** All bricks will be shipped to the Post. We will notify you when it arrives and you are welcome to stop by and see the brick you have purchased.
- **What Will Become of My Brick?** It will be placed near the Flagpole at the Post and will be part of the landscaping design we are working. If you are a landscaper or know a good one (preferably a Veteran), have them contact our Adjutant.
- **How Long Will this Fundraiser Effort Last?** We plan to only sell as many bricks as needed for the first phase of the landscaping project. Currently, that is anticipated to be 600 bricks, but that number may change depending on brick sizes purchased and the final design approved by the Post.

## BRINGING A LITTLE SOUTH TO THE WEST



Elementary, Junior High, and High Schools have certainly changed since I was a student for those 12, almost 13 years attending a Memphis City School. You don't need to write in cursive when all you do is punch a key on a keypad or keyboard. And she had absolutely no clue about our nation's government and how it is designed to work. Even the basics of our Congressional makeup was foreign to her.

I guess I'm a little torn in how I feel about most of this. Thinking back on those subjects in school, my overall grades would have been much better if I didn't have to recite all the state capitals. And not having to remember the three Branches of our Government and what they are designed to do would have freed up my after-school homework hours. Okay, that last part wasn't completely true. I didn't spend an inordinate amount of time after school doing homework. I was supposed to, but it seemed other things kept getting in the way. While it wasn't Facebook or Snapchat, it was hanging out with my buds or spending time working on my car, or just working.

I learned the hard way this was not a good plan. Back in the day if you didn't do the work, you flunked. You either spent the next year in the same grade, or you went to Summer School. This was a very painful lesson, but one I learned and never repeated (pun intended). You learned the lessons; they didn't “dumb it down” so you could learn. You stepped up and did what you had to do to pass. Most of the time that meant studying when your friends were out having a good time.
