Thirty-three (33) Post 209 legionnaires attended the Saturday morning, February 21<sup>st</sup> General Membership Meeting. Congratulations to all who attended. Discussions took place concerning the disposition of the 7.4-acre lot owned by Post 209 and the vision to build/acquire a Post Home for Post 209. Also a motion was made to change the Bylaws. #### Change in the Bylaws

A motion was made to change Article X, Meetings, Section 5 of our bylaws. It currently reads: Ten percent of the members in good standing shall constitute a quorum for the conduct of business at a regular or special meeting. The motion was made to change this to read: Twelve (12) members, three (3) of which must be elected officers of Post 209, will constitute a quorum at regular and special membership meetings."

## **Finance Officer Report**

This position is open. It needs someone who knows Quick Books to fill it.

Many thanks to new Post 209 Legionnaire, Todd Delahanty, for updating and entering financial data in our Quick Books program. He worked at it Saturday afternoon after the February 21st General Membership Meeting and again Monday night, Feb 23rd.

The following report is from Commander Chuck Zeitvogel.

Current Post 209's expenses average approximately \$1,800 per month. Membership fees do not cover these expenses. The following expense information is for your consideration.

- \$9,362.00 Estimated Sub Total Annual Expenses. This divided by 12months is approximately \$780.00 per

This \$780.00 plus the Sub Total of \$1,009.00 monthly expenses listed above comes to approximately \$1,789.00 or \$1,800.00 rounded for over all monthly expenses.

This does not take into consideration what is paid out for Boys State/Scouting & Other Service Projects.

Donations to Post 209 are greatly appreciated. Recognition will be given in a future newsletter. The request for each member to donate \$120 per year or \$10 per month was in our February 2004 newsletter. Donations are needed for Post 209 to remain financially viable.

From Adjutant - Ann Foster

We now have 272 members for 2004 and need only 13 more for 100%. Dare we dream of 105% (27 more) or 110% (42 more)? I think it is possible, but it will require the support of the entire Post to make it happen! There has to be at least one person you know that is a veteran and does not yet belong to The American Legion. We live in a city full of veterans and yes I know that some belong to other veteran service organizations. However, you can belong to more than one and choose to be active in only one of them! As examples, I belong to the following: The American Legion, the Air Force Association (AFA), the Air Force Sergeants Association (AFSA), The Retired Enlisted Association (TREA), the Disabled Veterans Organization (DAV), and the Military Officers Association of America (MOAA). You may ask why so many and the answer is a desire to support and/or affiliate with those groups that are of my branch of service as well as how I served, i.e., both officer and enlisted. I belong to DAV as a 50% disabled veteran. Their magazine does an excellent job of keeping me up on disability issues for veterans. I have paid life dues in each of them. Thus, I do not have to worry about dues annually. Another way to look at this is the knowledge that the support of membership in each enhances the work of each. This is particularly true of the work each does at the national level to advance the concerns of veterans before Congress. I choose to be active in The American Legion, because it is the largest, the oldest, is family oriented and has an excellent record at the National, Department and local level. We have other members of our Post who belong to their branch of service veteran's organization as well as The American Legion. Examples are the Navy League, the Marine Corps League, the Korean Veterans, the Veterans of Foreign Wars, etc. So, let's make it simple. If you know someone who is eligible to belong to The American Legion, just call or write us with the name, address, and telephone of that person. We will take it from there. With your help we can go above and beyond our 100% goal.
