
I know that all of the American Legion believes in this and it is our duty to live by and promote this so that we can keep our country strong and make it better for all Americans.

Junior Vice Commander Eric Testorff

As a member of the Sons of the American Legion, I sometimes wonder about the wartime service of my dad, Richard Testorff. Dad almost never spoke of the War in the Pacific around us kids, although I know he was at times in the thick of it. He had friends from high school who didn't make it back, and I would sometimes think that he would rather just forget the whole thing.

Dad was a Gunners Mate on LST 123. LST was short for "Landing Ship, Tank". The original idea for these ships derived from the British. The evacuation of Dunkirk in 1940 demonstrated to the Admiralty that the Allies needed relatively large, ocean



-going ships that could handle shore-to-shore delivery of tanks and other vehicles in amphibious assaults. This idea eventually materialized as the LST, a large ship that could run right to the beach and open the bow door. A ramp was then extended to quickly unload the hold.

As a gunners mate, Dad was trained on the considerable armament of an LST: There was



a 3-in (76 mm) gun, six 40 mm Bofors guns, six 20 mm guns, two .50 cal machine guns, and four .30 cal machine guns. Dad's battle station was at the twin '40's, which, I believe, put him up at the bow.

LST-123 was assigned to the Asiatic-Pacific theater, and earned three battle stars: The Marianas operation: Capture and occupation of Guam-July 1944; the Leyte landings-October 1944; and the Lingayen landings in Luzon-January 1945. The Pacific War ended in August, and on 15 September, 1945, she was re-designated LSTH-123, (hospital ship), and

performed occupation duty in the Far East until mid-November.

Dad's ship was decommissioned on 22 March, 1946, and finally sold for scrap in 1948. Were he and his mates sad about their old ship's demise? I can't say for sure. Was he proud of his service and of the 123? He never did say, but there is one lasting clue: When it came time to name my oldest brother, who was born in December of 1946, Dad made sure his initials were: "L.S.T."

Computer Challenges

Question: What does Manila, The Philippines, and Boca Raton, Florida have in common? Answer: these are the two locations one gets referred to when calling for computer tech support, at least that has been my experience. Those who I have spoken with have been extremely courteous, spoke the English language extremely well, were highly knowledgeable, and overall tried to help with my computer issues. Why then have these contacts been so frustrating?

It's having to call because you're out of your element when it comes to computers; There is the challenge of getting through, when calling for help, and getting someone who understands my novice situation and is sympathetic to the computer challenges I'm having.

Here's my situation: I have "Microsoft XP Home Edition" on my desktop Gateway PC which I've had for ten or more years. And, it was being used mostly for e-mailings and various reports and letters over the years. Occasionally and then more frequently messages would pop up indicating Microsoft would soon stop supporting the XP Home Edition and to back up; files, etc., etc. Messages that for the most part were ignored and then one morning in November when nothing happened when I went to sign on to check e-mail and do some reports. The warnings came true and I offered up a few silent choice thoughts and finally accepted the fact that I needed a new computer.

I had heard that Microsoft 8.1 was the latest operating system and best way to go when buying a new computer and I decided on getting a lap-top PC without all the wires associated with a desktop, be mobile, and not take up a lot of room. And with that I purchased new HP laptop for a little over \$500.00. It was a nice one, enclosed in a red case with red keys on the keyboard and had a touch screen to move information about, and had more capacity than I needed at the time. After getting it home and out of the box I looked for an instruction book but there was not one. What I learned was that you had to sign on and open the program to access the instructions. Problem was how to sign on when the system did not recognize my e-mail address or pass words. And then, the red keys that looked good in the display model seemed small for my fingers I typed on the keys.

So, I ended up returning that computer for a refund and bought a basic Toshiba laptop for just over \$300.00, black in color, with larger keys, and less capacity but still with the Microsoft 8.1 operating system same as the HP had I felt like it would serve my purposes well. I'm still dealing with a learning curve and frustrations of how to use the Toshiba and 8.1 operating system, signing on to access the instructions. Fortunately, son-in-law in Lakewood helped me over Thanksgiving as well as another tech savvy son-in-law from Fort Worth helped over the Christmas Holidays.

And, still I called for tech support for the desk-top and reached those computer tech folks who settled in Boca Raton, Florida. We spent hours upon hours and their taking control of my desk-top to bring it back to life. I reached them when the AOL customer service lady told me I had AOL insurance with them for service up to \$750.00 and gave me a number to call. And - Yes, there they were - from Manila, The Philippines and Boca Raton, Florida. The AOL insurance did not cover their work, but they assist me for a price. It was \$399.00 for their tech support. Which they said they would be there for me and my desk-top and lap-top for three years. I bit the bullet – paid the price and hope the tech support is there when next needed.

My thought now is that our American Legion Post 209 might have some computer savvy members who would be willing to offer their services to members who are stymied when using computers. If you are one of the gifted ones, with computer background, please make it known. Perhaps we might arrange for classes within our Post facilities where you could provide informal guidance for those of us need help when it comes to computers. Think about it - Legionnaires helping Legionaries and no more calls to The Philippines or Boca Raton, Florida for help with computer questions.

The election of Post Officers is coming soon and all members are encouraged to participate. Please contact the nominating chairman, Ken Taylor, if you are interested in running for any position. All positions are voted annually during our April membership meeting, with the exception of the Service Officer and Judge Advocate, which is appointed by the Commander-elect. We will also vote on members for the Board of Trustees during the April meeting.

Roles and Responsibilities of Officers

Commander: You are entrusted with the supervision of the duties of all other Officers of the Post. You are the presiding Officer at all meetings and you must familiarize yourself with the policies and traditions of your Post and The American Legion.

Adjutant: Also known as the "First Sergeant." You are the Secretary of the Post. Post activities will revolve around you. The Adjutant is the Post personnel officer; maintains membership records, minutes of meetings, checks up and assists with the work of the other Officers and Committees. You publish official orders; announcements and instructions.

Senior Vice Commander: Your primary concern is membership. No Post can survive with out good membership. You should also be familiar with ceremonial protocols for regular meetings. A Vice Commander must be ready to fill in for the Commander upon a moment's notice.

Junior Vice Commander: You must be ready to promote your Post. The Commander will depend on you to provide programs that spice up the meetings and attract attendance. You should contact other Veteran and civic organizations so that each patriotic holiday and observance receives the attention it deserves. You are concerned with the pageantry of the Legion. You should also be concerned with the welfare of all fellow Veterans as well as with Veteran's affairs and rehabilitation committees.

Finance Officer: You will serve as chair of the Finance Committee and will be in charge of all receiving and disbursing of Post funds. You will work closely with the Post Adjutant in all matters relating to the finances of your Post.

Service Officer: You should be a dedicated person and should have a deep interest in fellow Veterans, the Post and the community. You are responsible for bringing to the attention of all Veterans and their dependents the rights and benefits granted to them by law. You must know how to utilize the expert services available through Legion channels as well as through local agencies. You should be ready to visit dependents upon a death of a service member. You may be called upon to serve as chair of Veterans Affairs and Rehabilitation Committee as well as working with children and youth committees or making hospital visitations. Appointed by the Commanderelect.

Chaplain: You must be a person capable of moral and intellectual leadership. You work closely with all other Officers of the Post. You should attend all meetings of the Post and Executive Committee. You should be ready to officiate when requested, at funerals of members. The Chaplain must also be ready to provide service to bereaved families of Post members.

Sergeant-at-Arms: You should know how to arrange the meeting hall, assist the Post Commander and Adjutant. You are the custodian of the Colors and in charge of Colors details during the presentation and retirement ceremonies. You should know how to display flags and their proper presentation. You are also responsible for maintaining order at all meetings.

Historian: You have the responsibility of preserving and compiling the records/photos (specifically through our Scrapbook and website) of our Post. You should <u>try</u> to attend Department Conventions and keep in touch with other Post Historians. [You are only encouraged to attend, not required.]

Post Executive Committeeman: You are a voting member of the Post Executive Committee, which is entrusted with the government and management of the Post. You shall be responsible to represent the interests of the general membership to the Executive Committee.

Judge Advocate: You will supply professional advice in the conducting of the Post business or to procure proper counsel. You are the interpreter of the Constitution and By-Laws of our Post. You may be asked to assist in auditing Post financial accounts. Appointed by the Commander-elect.

Bringing a Little South to the West Immediate Past Post Commander Jay Bowen

When I was growing up many people in the South believed in Corporal Punishment (a.k.a. a whoopin'). While I certainly had my fair share of visits to the "tool shed," I guess if I was being honest I would tell you every single one was deserved. Matter of fact, there were MANY times I should have gotten spanked and didn't. I don't know what spared the rod in those instances, but was always glad when it happened. A few of them I remember even today.

Probably the one that revisits me the most is the time I got a whoopin' from my Mother's Father, or Paw Paw. He was a devout Pentecost and had the patience of Job. He was almost 5' tall and about as big around. He was jovial, and more of a kid than I ever was. He only spanked me and my brother once as I recall. We were visiting them on their Arkansas farm and lit out one Spring morning to the gravel pit nearby. We took his .22 rifle and a box of his shells. The gravel pit was much fun and offered young boys hours of stuff to do, with something different each time we visited. This one morning we arrived at the pond in the "pit" and saw several bull frogs along the water's edge. They were huge, croaking so loud I think my grandparents could hear them a mile away! The ledge on which we stood watching the frogs was about 20' above the water. Back in the day, my brother Eddie (I just call him Bubba) and I were pretty good shots. We had a blast (pun intended) shooting the frogs in and along the water, and in no time shot up the entire box of .22 shells. After playing around a while longer we returned to our Grandparent's home. Paw Paw, noticing the box was empty, asked what we had found so interesting that we depleted his .22 shells. We told him of our great hunting expedition and how successful we were ridding the gravel pit of so many deadly predators. He looked around, checked our backs and ground around us, then asked where we had stashed our kill for the day. We explained we didn't bring them back, we just shot them and left them there. Now you should understand this is a man who farmed his entire life. He was a sharecropper, or as we used to say he "worked for the other fella." He never made enough money to actually own the acreage to farm for himself. It was all he could do to buy a farmhouse. The money he and my grandmother made from farming was just enough to pay the bills and buy seed for the next crop. So when Bubba and I broke the news that while we were the "Great White Hunters," not bringing home the game was unforgiveable. I remember my Paw Paw getting rid of a dog because he would not hunt, he didn't bark when strangers arrived, and he was not aggressive. This added up to a dog that didn't have a job, and my grandfather didn't have available resources to keep anything or anybody around that didn't "earn their keep." So the dog had to go. All of this came rushing back to me when my grandfather asked about the frogs. This kindly, gentle man looked sternly at us both and told us we had thrown away dinner for several days. It was too much for him, and we paid the price. My butt tingles even today when I think about it. I don't know if I was more hurt by the spanking, or letting down someone who I loved so dearly.

I guess my lesson from that day was that it doesn't really matter much what I think when visiting others and taking advantage of their cultures and traditions. I can either respect it or not go. I knew my grandparents ate Bull Frogs. I thought they tasted pretty good. I just wasn't thinking and didn't show proper respect. But you know what, I never hunted with my grandfather's gun after that without bringing home the "game." And I never got another whoopin' from him. Now I think I'll have some Frog Legs and think about Paw Paw and the gravel pits. More to come!


