**Commander Comments** - Chuck Zeitvogel

**Recommendation to Change Post 209 Constitution & Bylaws, adopted March 1993.**  
A recommendation to amend /change Article X, Meetings, Section 5 of the Constitution & ByLaws of Centennial Post 209, The American Legion, Department of Colorado, Adopted March 1993 is hereby made. Note the following.

**Article X, Section 5** - reads: "Ten percent of the members in good standing shall constitute a quorum for the conduct of business at a regular or special meeting."

**Recommend this be changed to read:** "Four percent of the members in good standing shall constitute a quorum for the conduct of business at regular or special meetings."

**Purpose of change:** Ten percent of the membership **has not** attended regular or special membership meetings for the past three plus years. Without a quorum of members in good standing business cannot be conducted officially at Post 209's regular or special membership meetings. This proposed Bylaw change, when approved, will allow for the transaction of business at regular and special meetings in a timely manner. And, meetings will then be in compliance with the Constitution & By-Laws of Post 209.

**Membership** has been approximately 285 this past year. This takes into consideration members that move in or out of Post 209. Ten percent of 285 members equals 28.5, this rounds to 29 members that are required to be at a regular or special membership meeting to have a quorum for the conduct of business. Attendance records indicate that on average 11 to 14

members have attended meetings over the past three plus years.

**The change to four percent vs ten percent** with a membership of 285 will require attendance of 11.4, rounded down to 11, members present at regular or special meetings for there to be a quorum. The number 11 is more realistically in line with the number of members who have attended regular and special meetings in the past. To repeat, this change will allow Post 209 to function and carry on business in a proper official manner in accordance with the Constitution & Bylaws.

**Note:** A vote will be taken at the regular - general membership meeting Nov 20, 2003 to be held at VFW Post 4051 located at 430 East Pikes Peak Avenue, Colorado Springs, CO to amend /change the Bylaws, Article X, Section 5 to read:

**"Four percent of the members in good standing shall constitute a quorum for the conduct of business at a regular or special meeting."**

**This notice** is given to Post 209 members in accordance with the Post's current Constitution & Bylaws, Article IX, Authority and Amendments, Section 2. It requires that written notice to change the Constitution & Bylaws be given to members at least ten days prior to a vote to amend or change the Constitution & Bylaws.

Legionnaires who are interested in the business affairs of Post 209 should attend the Nov 20, 2003 membership meeting.

**Veterans Day Parade**

The starting point, however, is expected to be near St Vrain Street with the parade going down Tejon Street to Vermijo Street.

The plans were briefed to members at the Oct 16, 2003 general membership meeting. Members present at that meeting encouraged the Executive Committee & Board of Trustees to continue with their considerations and discernment as to what might be in the best interest of Post 209.

The Executive Committee will provide periodic progress reports on this topic to Post 209

Legionnaire Francis Redington served as Chaplain, Legionnaire Ann Foster served as Sgt-At-Arms, Legionnaire W.W. Bandler served as honorary Fire Marshall, Legionnaire Bill Marshall assisted with monitoring the incinerator fire and Legionnaire Chuck Zeitvogel served as Commander.

A fire-truck and representatives from the Colorado Springs Fire Department Station 10 came by to observe the proceedings.

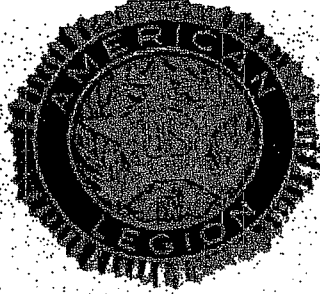
