### **OH THOSE GLORIOUS FLY GIRLS!**

When America entered WWII in 1941, Britain and Russia had their backs to the wall. Before long, thousands of American Navy and Merchant vessels were steaming across the Atlantic carrying planes, tanks and guns to Europe. Eventually, millions of G.I.s were involved in the conflict. Allies began massive bombing raids against the Nazis. They marched towards victory.

Every phase of American life was affected. By 1945, twelve and one half million men and women were serving in uniform.

In September 1942, a 20-something year old Millicent Peterson (Millicent Peterson Young) from Colorado Springs, responded to the call to serve. She, along with 200 more young ladies volunteered to undergo pilot training in the Army. This courageous leap of faith in America freed up male pilots to engage in combat missions over enemy territory. Millie, as she is warmly known among friends and family, often said, "We had no expectations of glory, we were civilians hired by the Army, we just had a sense of patriotism." These volunteers went to England to work. "We learned to fly all kinds of airplanes, from small Spitfires to Military B-17s." These pioneers were also ferrying vital aircraft replacement parts to military bases, or towing drones and aiding in communications.

At times, when they readied for their missions, the men would crack sarcastic remarks such as: "What are you doing girlie? Do you know what you are doing?" or "I should be in that seat." Millie would often just smile and think, "Oh well, we are changing the world for aviators."

The Women Air Force Service Pilots (WASPs) unit was disbanded at the end of 1944. These fantastic, valiant and faithful civilian women just went home. Many had to pay their own way back. Another chapter in WWII history was closed; temporarily.

On Tuesday, the 10th of March, 175 former WASPs now in their 80's and 90's were belatedly honored. 300 of the initial 1,000 aviators are alive today.

The ceremony took place at Capitol Hill where they were awarded the Congressional Gold Medal. A wreath laying ceremony took place honoring the memory of those who had gone before and logged over 6,000,000 miles.

### **GOOD FRIDAY AND EASTER**

These two days are not official holidays. However, many churches have special services that commemorate the physical death of Jesus Christ at the Cross overcoming death for us. His spirit became separated from His body. (John 3:16-17) On the third day, His spirit and His body were reunited eternally. (Luke 24: 1-10). This time never to be separated again. (Luke 24: 36-39). The resurrection makes it possible to return to God's presence. To receive that blessing, we must also live in accordance with His commandments.

Many people observe Good Friday by attending church, offering silent prayers and thanking God for Jesus Christ's suffering-passion. Many abstain from eating meat or they fast, signifying going without the usual luxuries as a form of purification. Easter Sunday is celebrated by events such as decorating eggs, which signifies new life or spring.

May the Lord bless us all at this time of soul searching and meditation.



## Latest News from the Department of Veterans Affairs



AP - February 26, 2010) The Department of Veterans Affairs (VA) will re-examine the disability claims of what could be thousands of Gulf War veterans suffering from ailments they blame on their war service, the first step toward potentially compensating them nearly twenty years after the war ended.

Secretary Eric Shinseki said the decision is part of a "fresh, bold look" VA is taking to help veterans who have what's commonly called "Gulf War illness." "I'm hoping they'll be enthused by the fact that this...challenges all the assumptions that have been there for 20 years," Shinseki told The Associated Press in an exclusive interview. These veterans have long felt the government did little to help them. The VA says it also plans to improve training for medical staff who work with Gulf War vets, to make sure they do not simply tell vets that their symptoms are imaginary-as has happened to many over the years.

The changes reflect a significant shift in how VA may ultimately care for some 700,000 veterans who served in the Gulf War. It also could change how the department handles war-related illness suffered by future veterans, as Shinseki said he wants standards put in place that don't leave veterans waiting decades for answers to what ails them. The decision comes four months after Secretary Shinseki opened the door for as many as 200,000 Vietnam veterans to receive service-related disability compensation for three illnesses stemming from exposure to the Agent Orange herbicide.

About 175,000 to 210,000 Gulf War veterans have displayed a pattern of symptoms that include rashes, joint and muscle pain, sleep issues and gastrointestinal problems, according to a 2008 congressionally-mandated committee that based the estimate on earlier studies. But what exactly caused the symptoms has long been unanswered. Independent scientists have pointed to pesticide and pyridostigmine bromide pills, given to protect troops from nerve agents, as probable culprits. The 2008 report noted that since 1994, \$340 million has been spent on government research into the illness, but little has focused on treatments.

Last week, Secretary Shinseki and Senator Jay Rockefeller (WV), a member of the Senate Veterans' Affairs committee, met privately in Charleston, West Virginia, with several Gulf War veterans. In an interview after the meeting, Rockefeller told the AP that Shinseki's background as a former Army chief of staff made the changes possible. He said either the military has been reluctant over the years to release paperwork related to the war or kept poor records about exposures in the war zone, which made it harder for the veterans to prove they needed help. "The paperwork isn't very accurate, but the pain is very real," Rockefeller said.

Secretary Shinseki has publicly wondered why today there are still so many unanswered questions about Gulf War illness, as stricken veterans' conditions have only worsened with age. Last fall, he appointed a task force led by his chief of staff, John Gingrich, a retired Army colonel who commanded a field artillery battalion in the 1991 war, to review benefits and care for Gulf War veterans. Changes stem from the task force's work. Gingrich said in an interview he feels a personal stake because some of his own men who were healthy during the war are dealing with these health problems. Gingrich said the VA isn't giving a new benefit to Gulf War veterans, just making sure the claims they submitted were done correctly. "We're talking about a culture change, that we don't have a single clinician or benefits person saying 'you really don't have Gulf War illness, this is only imaginary' or 'you're really not sick,'" Gingrich said.

A law enacted in 1994 allows the VA to pay compensation to Gulf War veterans with certain chronic disabilities from illnesses the VA could not diagnose. More than 3,400 Gulf War veterans have qualified for benefits under this category, according to the VA. The VA says it plans to review how regulations were written to ensure the veterans received the compensation they were entitled to under the law. The VA would then give veterans the opportunity to have a rejected claim reconsidered. The VA doesn't have an estimate of the number of veterans who may be affected, but it could be in the thousands. Of those who deployed in the Gulf War, 300,000 submitted claims, according to the VA. About 14 percent were rejected, while the rest received compensation for at least one condition.

## A Little Known Secret for Veterans

The Special Pension for Veterans' Aid and Attendance pays up to \$1,644 a month, \$19,736 annually, toward assisted living, nursing homes or in-home care for veterans 65 and older who served at least 90 days and one day during wartime — stateside or overseas. Veterans and their spouses can receive up to \$23,396 annually and spouses of deceased veterans, \$12,681.

Yet, an estimated \$22 billion a year goes unclaimed, said [Don Soard](#), a volunteer with Operation Veteran Aid in [Oklahoma City](#). In 2007, only 134,000 seniors nationwide received the benefit, which was established in 1952.

Soard started his volunteer mission two years ago, following the deaths of two family members who served in WWII.

"If they'd known about this benefit, they'd have a much better quality of life in later years," he said. "Without it, many vets are forced to go on [Medicaid](#)."

## **President Obama Signed Veteran's Emergency Care Act**

President Obama signed into law the "Veteran's Emergency Fairness Act of 2009."

This important legislation amends existing statutes to allow the VA to reimburse eligible veterans for portions of emergency treatment not covered by their private insurance.

Before this change in law, VA could only pay outside hospitals directly, or reimburse veteran's in cases where they did not have private health insurance.

## **Speaking of Veterans Benefits**

Are you enrolled in the VA Health Care system?

When I ask veterans why they aren't enrolled in the VA Health Care Program, the reply that I hear most often is that I make too much money, or they wouldn't let me enroll. Those same veterans 3 years later told me they lost their job, became unemployed or had to accept a job at lesser pay.

What I am trying to get across to you, is that you should be enrolled in the VA Health Care System because you do not know what the future holds, especially when you are considering what is going on today in our economy.

A few years ago, Congress stated the VA had to define who they were serving and how many. At that time, Congress was going to tie funding to the enrollment of Veterans in the Health care arena.

Back then you may not have qualified, but now you do. If you would have been enrolled you could possibly be receiving care and benefits that you don't know about.

Do not rely upon my words or those of those famous lawyers we had in the barracks on active duty.
