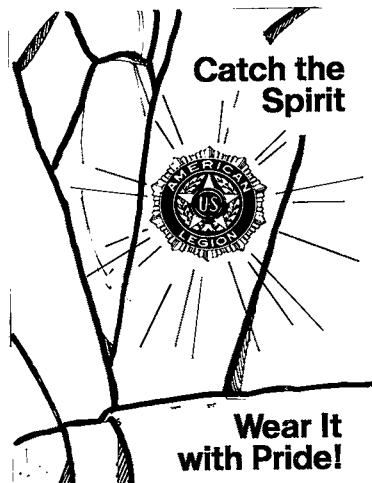
If some of the information in the articles provided make you upset, you should also read this month's Legionnaire Magazine in which are articles concerning homeless veterans and their plight.

VETS GET UNHEALTHY CARE AT SOME VA SITES. GAO SAYS

Several allegations raised before the House Subcommittee on Human Resources and Intergovernmental Relations in recent testimony by Mary Ann Curran, a registered nurse with the General Accounting Office who headed up a study of VA health care quality.

At one medical center, post-operative notes were not signed by supervisory physicians in 75 percent of the cases.

Curran said, "We discovered several cases of patients who had died because of errors made by unsupervised interns or residents.

The purpose of the investigation was to evaluate the quality of health care at VA hospitals. Curran said an examination of records showed several hospitals with large numbers of patient complications and other indicators of substandard health care.

Each year, VA hospitals provide inpatient and outpatient care to more than 22 million veterans. "Our system gives quality care to our veterans and this fact is widely recognized," said Dr James W. Holsinger, Jr., VA's chief medical director, testifying before the subcommittee.

Holsinger outlined to the subcommittee various programs and policies his office established to ensure veterans are receiving quality health care.

"Our patients are older, sicker, and more complex than the average patient. This makes it even more important that we constantly improve our system."

Curran also visited six VA hospitals to determine if computer analysis of problems actually reflected the quality of care given to veterans.

In many cases, attending physicians did not examine patients. In one case, a patient lost a leg because he was not checked regularly.

"In another case", Curran said, "a patient's body was cold upon examination by a doctor, indicating that the patient had been dead for several hours before anyone discovered him."

Curran said one of the worst cases she witnessed was at the Cheyenne VA Medical Center where a patient with bladder cancer was forced to wait for treatment because the staff urologist had resigned over a contract dispute. After 454 days, a surgical officer asked the hospital's intensive care unit director to examine the patient. He found the patient restrained in his bed, suffering with an untreated infection. The veteran was transferred to Denver VAMC where he later died.

American Legion officials said the report reflected the consequences of under budgeting VA medical programs.

"Spending for these programs has been dismal over the last decade," said John Hanson, director of the Legion's VA & R Division in Washington.

VA inspector, General Stephen A. Trodden, whose office is responsible for constant monitoring of health care and its delivery, said that improvements have been made since Holsinger took over as chief medical director in 1990.

TEMPORARY
FINANCIAL
ASSISTANCE
PROGRAM

Administered through the National Americanism and Children and Youth Division, TFA has assisted the children of thousands of needy veterans.

"Since 1925, the Temporary Financial Assistance program has been a lifesaver for families in a bind who have tried but couldn't get help from VA, the government or social services agencies," said Eugene V. Linquist, chairman of the Children and Youth Commission.

To be eligible, an applicant must be a war era, honorably discharged veteran. The veteran, however, does not have to be a legionnaire to receive assistance.

Another prime consideration are the needs of minor children in the home.

The Post forwards the application to the Department Adjutant and Children and Youth Chairman for review.

Two types of grants are available, and one or both may be awarded to needy families. Maintenance grants provide money for food, shelter, utilities, household supplies or other specified needs based on the recommendations of a Department's Children & Youth Chairman.

A medical grant can be used for basic medical and dental care, surgery, dietary needs, even hospitalization. Medical grants require a written statement from the care provider specifying the problem, treatment plan and estimated cost. The grants are for existing medical needs and cannot cover previous medical expenses.
