But as my angel took each piece of cloth off the pile, I noticed how ragged and empty each of my squares was. They were filled with giant holes. Each square was labeled with a part of my life that had been difficult, the challenges and temptations I was faced with in everyday life. I saw hardships that I endured, which were the largest holes of all.

I glanced around me. Nobody else had such squares. Other than a tiny hole here and there, the other tapestries were filled with rich color and the bright hues of worldly fortune. I gazed upon my own life and was disheartened.

My angel was sewing the ragged pieces of cloth together, threadbare and empty, like binding air.

Finally the time came when each life was to be displayed, held up to the light, the scrutiny of truth.

The others rose, each in turn, holding up their tapestries. So filled their lives had been. My angel looked upon me, and nodded for me to rise.

My gaze dropped to the ground in shame. I hadn't had all the earthly fortunes. I had love in my life, and laughter. And now, I had to face

the truth. My life was what it was, and I had to accept it for what it was.

I rose and slowly lifted the combined squares of my life to the light. An awe-filled gasp filled the air. I gazed around at the others who stared at me with wide eyes.

Then, I looked upon the tapestry before me. Light flooded the many holes, creating an image, the face of Christ. Then our Lord stood before me, with warmth and love in His eyes. He said, "Every time you gave over your life to Me, it became My life, My hardships, and My struggles. Each point of light in your life is when you stepped aside and let Me shine through, until there was more of Me than there was of you."

May all our quilts be threadbare and worn, allowing Christ to shine through.

## **ATTENTION, ATTENTION ALL VETERANS**

Have you had a disability awarded by the VA, submitted a claim to upgrade your disability, and received that upgrade to your disability?

I recently had my disability upgraded. I had an appointment at the Denver VA and decided to get some prescriptions filled. To my surprise, my file had not been upgraded to show that my medications were now service connected and that I did not have to pay for them.

When I asked why my records weren't updated, I was informed that the Denver Regional Office did not talk to the Denver VA Hospital and therefore the files didn't upgrade.

The Patient Advocate told me the same thing. The advisor said that the two VA's do not talk to each other and, "if I wanted my files updated, I would have to take a copy of the award letter to the VA Clinic on Spruce street and they would have to forward it."

Also, if you did get an upgrade and papers were sent to you to update your beneficiary file, you should make sure all information is correct.

If you have any doubt and you feel you should check this out just TO BE ON THE SAFE SIDE – DO IT! You might feel better knowing for sure that all of your information is correct.

Information has been received that "if you haven't registered with the VA by now, it will be quite awhile before you can have an appointment". They are over loaded and waiting to find ways to help all of us Veterans.

I have been talking with prospective members to The American Legion and Centennial Post 209. While talking with them one of them asked me why I do what I do with The American Legion since I am not retired from any military organization.

My reply to him was that, "just because I did not retire from the military doesn't mean that I do not care about the men and women who are answering the call of our great country just as we did". I also informed him that this organization was not founded on the necessity of a Legionnaire being retired before he could join. In fact, we have many Legionnaires who are still on active duty and belong to our great organization.

He asked what benefit is The American Legion to me? How have I benefited from the organization? I asked him how he bought his house and his reply was using the VA. I asked him if he went to college when he got out of the military. His reply was, "The only reason I went into the military was to get the education benefits".

I informed him that his ability to buy the house and to attend college was because of the veterans who went before him and secured those benefits so that he was able to use them.

I also told him of the medical benefits (such as they are) and the VA Hospital system that would not be around to help him if it wasn't for the ones who have gone before us. We wouldn't have any of this to the degree we do if it wasn't for the veterans.

The thing that I did not tell him to the fullest extent was of the fun that can be had while working the various programs, and meeting Legionnaires from all walks of life when they attend meeting and functions. I didn't tell him of the look when a hospitalized veteran sees a Legionnaire in his cap, walk into his room at the hospital, knowing that the individual who just walked into his world had gone through some the things he had and was there to cheer him up a little bit. Or, the looks on children's faces when they ask you questions about your military service and how some of them hold you in awe. Think about that and get your friends to join this great organization today.

## **Spelling Bee – USA**

**WASHINGTON DC**—During the National Spelling Bee this week in the nation's capital, Islamic spectators became outraged upon discovering that the USA was embedded in the middle of Jerusalem, Israel's holiest city

The revelation was made by Douglas Levin, an eighth grader at the Joseph Lieberman Day School in Rockville Center, Md. When young Levin was asked to spell the word Jerusalem, he replied: 'J...E...R.....USA.....L...E...M.'

An audible gasp sounded from Muslim onlookers, who realized for the first time a USA presence in the holy city. Muslim parents immediately protested the spelling contest, citing American bias toward Israel. 'It's a clear violation of church and state,' said Muhammed Ahlee, lobbyist for the Arab group Holy Shiite.

Bee officials quickly denied any wrongdoing, asserting that the Muslims were merely disgruntled because Rajeed Raheed, a seventh grader from Al Kaydah Junior High, had been eliminated earlier for misspelling Afghanistan as Afghanustan.


When it comes to offering a helping hand, the Auxiliary is active in organ-donation programs, blood-donor drives and working with Habit for Humanity International, which helps fill affordable housing needs for families across the world.

When it comes to serving our veterans, Auxiliary members are on the front line, providing thousands of volunteer hours each year in VA facilities. The Auxiliary provides gifts for veterans to give to their families during the holidays.

For more than 70 years, the Poppy Program has been a part of the Auxiliary. Veterans in Auxiliary sponsored poppy shops make the red handcrafted poppies. These shops provide supplemental physical and psychological therapy needed by the hospitalized and disabled veterans. Each veteran is paid a small amount for assembling the poppies. The flowers are given out in exchange for donations.

All proceeds from this distribution of the poppies are invested in local programs, benefiting veterans and their families. These are just a few of the selling points of the American Legion Auxiliary. Legionnaires who are successful in selling the nation's largest veterans organization will have little trouble selling their counterpart as well. The American Legion and The American Legion Auxiliary need each other. They compliment each other.

Yes, they go hand-in-hand, providing many of the same services and promoting similar programs. Since 1919, the two organizations have been working together. We need to continue to work together. The veterans and service members of this country deserve it.
