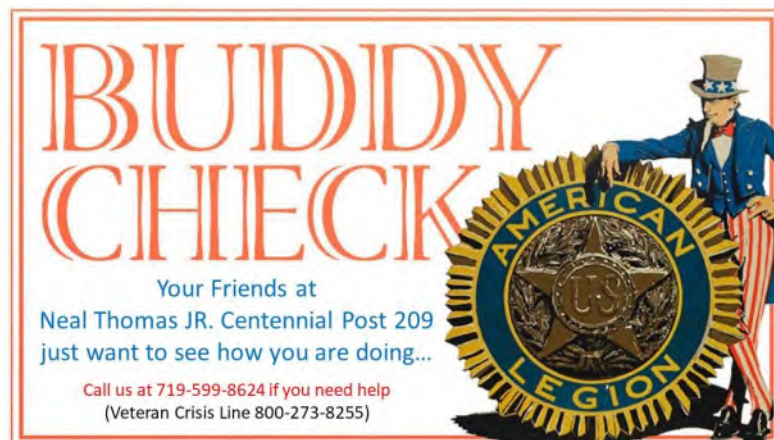

FROM THE DESK OF THE SR. VICE COMMANDER

Why did you join The American Legion? I am sure this is a question you've been asked once or twice. My answer always refers to the four pillars of the American Legion. If you don't know, they are Children & Youth, Americanism, Veteran's Affairs & Rehabilitation, and National Security. These are among the main reasons I am a member of The American Legion.

Children & Youth includes three main objectives; to strengthen the family unit, work with organizations that provide services for children, and provide communities with programs to meet the needs of children & youth. One of the biggest and most noticeable ways this is accomplished is with The American Legion Child Welfare Foundation (CWF) and Temporary Financial Assistance (TFA). The Sons of The American Legion have taken the CWF on as one of their main fundraising objectives. The CWF annually gives money to non-profit organizations to help in research and education to educate the public about the needs of children. The TFA is used to give financial support to veterans in need of assistance with children in the household.

I'd like to share an event that I witnessed the other night that made me think of our Children & Youth pillar. I recently attended the Friends of the NRA Banquet. I was there in support of our Young Guns program. The Friends of the NRA have awarded grants for several years to our Young Guns Program (An Americanism program). Money received from this organization has been used to buy air rifles, targets, and other much needed items for a successful program. The last event of the night was an auction for two kids' bikes. The winners of the auction were able to pick a child under the age of 12 that was in attendance to race around the room. Savannah Mussmann, daughter of Legionnaire Mike Mussmann was selected to ride one of the bikes. She won the race and after the race was over, she was given the bike she had ridden. She told her dad the bike was hard to ride because it was too small for her. She said she was going to take the bike and give it to another little girl instead of keeping it. Mike told her that it was her decision, so she went up to get the bike and told the director she was going to give the bike away and then the entire room watched as she took it to another girl in the audience and gave her the bike. Mike was a very proud dad when he watched her do this. We, at Post 209 should all share in Mike's pride for Savannah's very generous gesture. The next time you see Savannah at a dinner (which is almost every Friday night), please let her know how much you appreciate her unselfish act.

The recommendation to use Rod Ermel Associates was made at the March Post Executive Committee Meeting so that the tax filing process will be completed on time. Everything for the preparation of the Post's 2021 tax filing has been provided to our POC at Rod Ermel Associates. The completed return should be available by the time you are reading the newsletter.

More work is going into the annual budget in order to start planning for future expenses. Some of the bigger expenses, such as insurance, will be easier to manage by setting aside a monthly amount into a budgeted line item in the account ledgers. This will help the Post avoid large surprise bills and better manage the Post funds when new ideas are explored for implementation.

Improved budgeting will help with preparing for things like increased costs for the Post utilities. As many are aware from their own utility bills, costs have gone up quite a bit lately. Different scheduling options for the thermostats are being explored to better optimize the heating/cooling and hopefully reduce the impact to the future bills. Additional ideas on how to reduce utility costs are also always welcome.

We are really seeing the Post returning to our pre-COVID status supporting OUR Veterans in the community. Dinners are busier with many more members coming out every week, which helps with providing funding for the Post to continue the different programs. As always, remember that any fundraising idea – big, small, unconventional (think about the impact of Kellie's Stick Pony Race) – is worth consideration to help us get there. A little note to add here is that we will need your help with the implementation of your new idea if it is decided to move forward with it, especially if the idea is something you have done before.

FROM OUR SAL COMMANDER

SAL SQUADRON 209 GENERAL REPORT

The Members of Squadron 209 are reminded that 2021 memberships are now expired as of 31 December 2021. With our current Squadron Membership at 97% of 2021 and with the influx of several new members in past months, Squadron 209 has the opportunity to increase our membership for the first time since the beginning of the pandemic.

At the recent 12 March Post General Membership meeting, I made a plea requesting the Legion members assist us in meeting our 2022 Child Welfare Foundation (CWF) goal of \$1,500, which represents about \$1.25 for every Post family member. CWF is an important American Legion Program that provides grants to nonprofit organizations for projects that contribute to the physical, mental, emotional and spiritual welfare of children. Grants are only given to entities that help U.S. children over a large geographic area and are not awarded for day-to-day operating expenses or special operating expenses. It is heavily focused on and supported by the SAL and I'm very gratified to report after passing around the Pink & Blue Piggies for donations to the approximately 40 members present at the meeting we collected \$97 in the Pink Piggie and \$94 in the Blue Piggie which will bring us close to meeting our CWF Goal for 2022. My Thanks to All those Legion members present at the Meeting who generously donated.

About 6 Squadron Members have accumulated the 10 designated SAL & Post Family Participation activities necessary to complete the Squadron 209 Participation Incentive Reward Program approved by membership in mid 2021 and have received their SAL Allegiance Polo purchased for them by the Squadron. Eligible activities to achieve this award are detailed on the Post SAL 209 webpage in a downloadable participation checklist which may also be requested from any Squadron Officer.

Additionally, the January 2022 Membership meeting voted to initiate an attendance DOOR PRIZE for a \$50 Gift Card as an incentive thank you for attending and participating in SAL Squadron 209 Monthly Meetings. Members will receive an entry ticket for each SAL Squadron 209 Monthly Member Meeting they attend and a winner will be drawn from eligible entries each quarter.

Nominations for 2022-2023 Squadron Officer positions are being taken at the March 2022 meeting with Officer Elections to be held at the 26 April, 2022 meeting where nominations from the floor may also be entertained. All Squadron Officer positions are open and available to any member willing to make the commitment to serve and they include: Squadron Commander; Sr. Vice Commander; Jr. Vice Commander; Adjutant; Finance Officer; Chaplain; Sergeant-at-Arms; Historian; and Executive Committeeman/Squadron Advisor. Interested members may consult position descriptions and expectations by reading the Constitution, By-Laws & SAL Handbook available on the SAL 209 page on the Legion209.org Post website or by contacting your current Squadron Officers. While these are volunteer positions, interested members are asked to carefully consider and take seriously the time & commitment to the success of Squadron and their fellow members that serving in these positions entail.

FROM OUR HONOR GUARD CAPTAIN

Fortunately, the two Final Honors requests that were denied in February due to not having personnel available to support could be covered (after the last article was written). Unfortunately, we did have to deny a request earlier this month. Denying requests to support Final Honors for a Veteran who earned those Honors is the hardest thing we have to do. This is where the Honor Guard continues to need the most help – providing the Final Honors earned by Veterans, like we hope someone will be there to support the Final Honors we earned when OUR time comes.

The Colorado Military Funeral Stipend Program is still going strong, with our Honor Guard continuing to submit qualifying events regularly. As mentioned last month, the Honor Guard developed incentive options presented at the March Post Executive Committee Meeting. The approved incentives are going to be phased in over the next few months and will be provided based on the Military Stipend Funds received. The first incentive being implemented, effective immediately, for being an Honor Guard member supporting Final Honors events is a Fuel Stipend. For every two (2) qualifying events an Honor Guard supports, a payment of \$5 will be earned to help defray the fuel costs from supporting the events. The Fuel Stipend is capped at ten (10) qualifying events (\$25) per month and will be paid to the Honor Guard members at the end of each month. As always, the biggest incentive for being an Honor Guard member is the sense of pride you get by helping provide Final Honors for OUR Veterans and supporting OUR Community.

And for the normal ending part of the article: while not everyone has a lot of time to participate in the Honor Guard, all someone needs is the time to participate a night or two for training meetings (2nd & 3rd Tuesday of every month) and even just **ONE** event a month. A meeting or two and one event a month is only 3-5 hours. Those 3-5 hours makes a difference for a Veteran and their family. Those 3-5 hours a month can also make a difference for you! If another 10 to 15 members of the Legion, Sons, or Auxiliary *gave back* with 3-5 hours a month, the Honor Guard could possibly not have to keep turning down requests. If you do not remember/know how to march or fold the flag, we will teach you. The only two items that a new Honor Guard member needs to get on their own is a Legion cap (or SAL/ALA as applicable) and shoes (multiple options available). All other uniform items that you need are provided by the Honor Guard. You do not have 3-5 hours a month? That is okay, you can still help the Honor Guard by telling others in the Legion, Sons, or Auxiliary (Post 209 or other Posts in the area) about what the Honor Guard does and the importance of growing in order to meet the increase of requests to support OUR Veterans. WALK OF HONOR

Buy A Brick Fundraiser!

We are re-introducing an exciting fundraiser for our Post. We are partnering with Polar Engraving to offer our members, family, friends, and our corporate Veteran-friendly supporters an opportunity to purchase an engraved brick to adorn our landscaping project we are working. The engraving uses the same technology as used on tombstones so it's extremely durable. Here are some FAQs:



- **What Are We Having?** A Brick Fundraising Event
- **Why?** To Further Funding of our American Legion Programs
- **What Size Are the Bricks?** 4"x 8" or 8"x 8" bricks for individuals, and 8"x 8" or 12"x 12" bricks for our corporate supporters.
- **What are the Costs for the Individual Bricks?** Prices vary depending on size, style and lettering desired, but typically range from \$90 to \$200. For the 8x8 or 12x12 bricks, you can add a second emblem. Contact the Adjutant for ordering details. There is **NO** additional cost for the second emblem on the larger bricks.
- **What are the Costs for the Corporate/Veteran Supporter Bricks?** Again, prices vary depending on size, style, and lettering but typically range from \$250 to \$500.
- **What is the Difference between Individual and Corporate Bricks?** Individual bricks are identified for Veterans, and family members of Veterans wishing to purchase a brick to honor their Veteran. The corporate bricks are for our Veteran-friendly supporters and businesses who wish to show their continued support to our Nation's heroes by purchasing a brick.
- **Is the Brick Purchase Restricted to Members of the Post 209 Family?** No. We encourage members to buy a brick for themselves as a lasting memory of their association with Post 209. We also welcome anyone to purchase a brick for their Veteran loved one, or to show their support to our Veterans.
- **Can I Buy a 12"x 12" Brick for Myself/Loved One?** Absolutely!
- **Where Do I Go to Buy a Brick?** We have a link on our website. Just visit legion209.org and click on "Walk of Honor." Or, you can visit <http://polarengraving.com/ALPost209> to buy your brick. The site is very user-friendly and will walk you through the design and purchase. You will be able to see a preview of your brick before finalizing the purchase.
- **How Do I Pay For the Brick?** We have the site setup to accept payment via PayPal or by check. PayPal is an extremely safe way to purchase a brick and you don't need a PayPal account to use it.
- **Where Will the Brick Be Shipped?** All bricks will be shipped to the Post. We will notify you when it arrives and you are welcome to stop by and see the brick you have purchased.
- **What Will Become of My Brick?** It will be placed near the Flagpole at the Post and will be part of the landscaping design we are working. If you are a landscaper or know a good one (preferably a Veteran), have them contact our Adjutant.
- **How Long Will this Fundraiser Effort Last?** We plan to only sell as many bricks as needed for the first phase of the landscaping project. Currently, that is anticipated to be 600 bricks, but that number may change depending on brick sizes purchased and the final design approved by the Post.
- **Will I Have an Opportunity to Buy a Brick Later?** Quite possibly. It depends on what is decided/approved for the next phase of our project.
