

We are actively working to build a Post Home for Post 209. We have had some problems which slowed us down. we purchased the property, we checked insure that the property properly zoned for the purpose of building a Post Home, and that we could serve alcoholic beverages. three years since we purchased the property, the definition of what you can build in this zone has changed. We are, therefore, going to have to go through the process of changing the zoning to allow us to build a Post We submitted that request on April 19. This can take three months We will be working with the architect on construction contractors' bids and financing so that when approved, we will be ready to start construction.

ADJUTANT ANNOTATIONS - ANN FOSTER

I write this it is Wednesday evening, 24 April, and I want to let you know what happened to me when I attempted to make an appointment at the Academy Hospital today. I found I was no longer in the "system" and the records unit did not initially seem to know what had happened to my two volumes of medical records. After a SSgt from the Records unit and I talked, he was able to determine that my records were in a staging area getting ready to be shipped to the Personnel Records Center National (NRPC) in St. Louis. He said he would go to the staging area and bring them back to the hospital. Then proceeded to help me get back into the Eventually the Retiree "system." Clinic that I thought I had been enrolled in all along was able to arrange for me to be seen in the afternoon.

Why were my records being shipped out? I am usually healthy for quite a spell and do not need to be seen every year. Thus, they decided I must not be around anymore. Since they had to go through about 80,000 records, they don't have the money to send you a card telling you what they want to do. The real point is that if you have medical records at any of the military

facilities, Academy, Peterson Clinic or Evens, and you have not been seen in the past year, you may want to check out the status of your records. If your records are at the Academy, telephone 472-5148 or 5149 or write 10th Medical Group/SGSTO, 4102 Pinon Drive, Ste 100, USAFA, CO 80840-4000 to request that your records not be retired. Ask that your records be pulled, hang onto the phone as it took twenty minutes for mine to be found. Whichever base has your records, send a memorandum to that medical unit, asking that your records be held and not retired. I may enter this idea into the Air Force Suggestion Program and will suggest it to others who may be facing such a problem. lesson learned here is that we can no longer make assumptions concerning our records or status at a military treatment facility. It will be our own responsibility to check this on a regular basis. I plan on doing it every six months or so. I hope my experience may be of some value to any of you who may think you have medical one of the military records at treatment facilities.

I would like to thank the 16 other members of the Post who attended the meeting in April, who had confidence in me, as they re-elected me to the position of Finance Officer. This is even after I told everyone that with the advent of the Post Home being built

and the expertise that I have would have been reached and that they would have to hire a person or elect a person who has more capabilities than I do.

BELOW IS A SAMPLE LETTER ON HOW VETERANS CAN SPEAK OUT! IT IS BETTER IF YOU DO IT IN YOUR OWN HANDWRITING OR TYPING!

Dear Elected Representative:

I am an angry American military veteran. I was selected by you to defend our country. You were selected by me to honor the inherent contract that comes with the possession of a DD Form 214.

Military retirees cannot receive adequate health care.

Military retirements are being administratively reduced.

The Department of Veterans Affairs budget is being attacked from all directions and needed services are in short supply or non-existent. Veterans eligibility for health care from VA is being reduced or eliminated. Disability compensation applications are taking nine or more months to process, because you keep cutting VA staff while the number of new veterans increases.

Veterans preference in the federal Civil Service and the Post Office is being circumvented. Department of Labor Veterans Employment Specialists are being reduced while demand for services increases.

Desecration of our flag seems not to bother some of you, but to those of us who presented it to loved ones of our fallen comrades - - - it bothers us!

There are 27 million of us who possess a DD Form 214. You will not mainstream us, nor will you make us disappear despite your efforts. We were and still are, America's first special interest group. We are different, because we served our country, right or wrong. Some of us came home in pieces, some came home in caskets, and some never came home! But, watch for us in November, we'll be there. We are America's veterans, your veterans.
