Members' Skills Bank. The collection of professional & skills information from members was started two months ago. This is an on going project. We need to hear from all our members to



Benefit for "Operation Back to School"

Operation Back to School, Holiday Toy distribution, Prescription Plush and Earn-A-Bike is a part of Christmas Unlimited.

Operation Back to School raises money for student's within District 11 and a couple of others who can't afford supplies for school.

Earn-a-Bike is for at risk kids. Some of these kids are not allowed to drive a vehicle. They get the opportunity to refurbish two bikes and they get to keep one of them.

Important Letter To Post 209 General Membership

The following will be discussed at the General Membership Meeting, June 19, 2003:

A. On April 28, 2003, Post Commander Chuck Zeitvogel and Property Committee Chairman Bill Marshall met with Colorado Springs City Planning Department and Public Works City Engineering personnel to discuss the Post property at Austin Bluffs Parkway and Old Farm Rd. Meeting results:

1. The property is **NOT PLATTED**.

2. An estimate to have the property platted to include, but not limited to; drainage fee, filing fee, planning fee, park dedication fee and school impact fee, plus cost to have the drainage study done is \$45,000-\$50,000.

3. All fees are paid upfront.

- 4. The cost for sewage, power, gas, drainage, and phone is estimated at \$60,000.
- B. The property was appraised by Park and Associates on September 19, 1999, with an approximate value of \$2.00/SF, total estimated value, \$643,000. Today's approximate value is \$3.00/SF, total estimated value, \$1,200,000.
- C. At the Post Executive Committee meeting May 1, 2003, the above items were discussed and it was concluded that it is not cost effective to have the property platted unless the membership decides to build a post home on it.
- D. Based on paragraphs A-C, there are several options for the property that the membership must decide on:
 - 1. Sell the property and use the proceeds to purchase a building for a post home.
 - 2. Divide the property, sell part, and use the proceeds to build a post home on the remaining parcel.
 - 3. Lease and let the lessee build to suit its needs. Use the revenue to acquire a building for a post home and have a continuing source of income.
 - 4. Sell the property and take the note with no less than \$500,000 in cash, thereby providing income to acquire a building and revenue to continue operating.
 - 5. Exchange the property for an already existing building for a post home with the expressed understanding that we must come out in the BLACK in order to have funds for fix-up and operating costs in the out-years.
 - 6. Do nothing and continue to pay taxes.
- E. It is imperative that all members attend the meeting on **June 19th** to discuss and vote on this vital issue. Whoever attends this meeting will be deciding the future of Post 209, which is dependent on the resolution of the property issue.
