Hi Legionaires!

AMERICAN LEGION REPORT OF SERVICE OFFICER

You probably have read or heard some controversial reports of people who are connected to a machine in a hospital for several months or years and no one will pull the plug.

In Colorado a LIVING WILL is legal. If you do not want your family to be faced with this burden, you may be interested in a LIVING WILL. There is a form that can be copied by hand, witnessed by two (2) people and be a legal document

On May 9th, 1989, the state of Colorado FORMALLY RECOGNIZED LIVING WILLS THROUGH THE COLORADO MEDICAL TREATMENT ACT. The law now allows a competent adult to declare that his life shall not be prolonged by artificial life-sustaining procedures if, at some future time, he or she becomes incapacitated by a terminal medical condition and is unable to reject such a procedure. The law does not authorize euthanasia or mercy killings.

WHAT ARE THE REQUIREMENTS?

It must be in writing and must be voluntarily signed by the declarant. It may be signed anytime, as long as the declarant is 18 years of age or older and is competent. The declaration MUST BE signed by two witnesses.

Many of you may be upset by the congressional attitude on the legality of burning the American flag. You can holler or scream but that will not do much good. 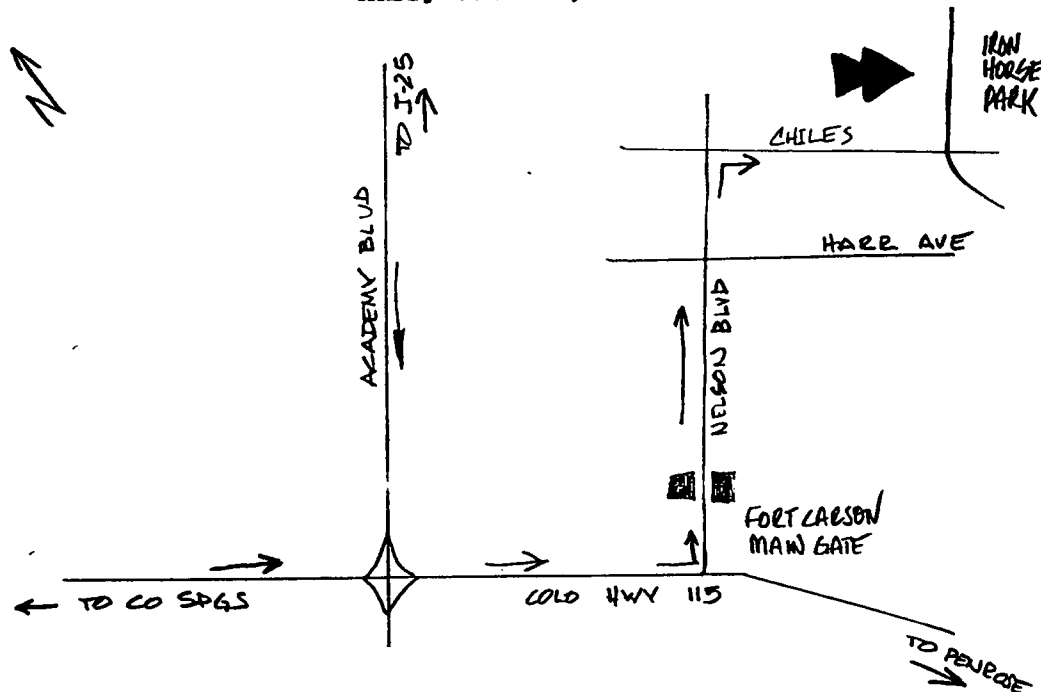

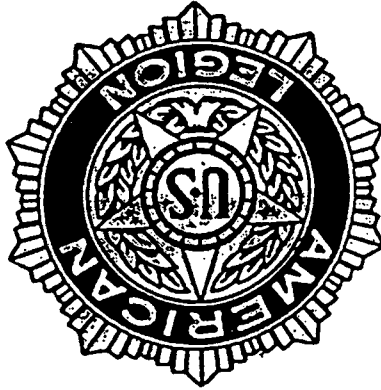
