### **ONLINE GULF WAR MEDICAL SITE LAUNCHED**

The Department of Defense, Department of Veterans Affairs, and the Centers for Disease Control and Prevention have launched an Internet site called Medsearch, as a central repository of Gulf War-related medical research. The goal of Medsearch's creators is to include all federally funded research into the illnesses of Gulf War veterans in one place. The site is indexed with plain language topic headings so that anyone can readily locate information. Headings include topics of particular interest to Gulf War veterans that may not be featured in other sources, such as pesticides and depleted uranium. Visit <http://www.GulfLINK.osd.mil/medsearch>.

### **NEW SOFTWARE TO SPEED VA CLAIMS**

The Department of Veterans Affairs plans to release software late this summer that will help veterans' service organizations prepare claims on behalf of veterans.

Currently, VSO representatives with power of attorney can request medical records only in paper form from the VA. With the new software, they will be able to review medical information in the veteran's electronic record at VA health facilities. The software has incorporated two features to safeguard veterans' medical records. First, the software provides read-only access to medical files, so users will not be able to add, delete or modify any information in the veteran's medical record. Second, the software limits a user's access to the medical records of only those patients for whom the VSO representative holds a valid power of attorney.

Representatives will have access to information from all VA hospitals in which a veteran was treated.



## From The Adjutant Ann Foster

We are into the 2003 membership drive and we are off to an excellent start. We have 30 renewals so far and 46 Paid-Up-For-Life or Permanent members for a grand total of 76. Our goal for 2003 is 297 based on our 2002 membership as of May 3rd, 2002, plus one member. Our current total is just a bit more than 25% of our goal. In addition, Commander Owens has appointed Bob Epps of Aurora Post 87 as Department Photographer and J.R. Menke of Fountain Post 1960 and Ken Sargent of Golden Post 21 as Assistant Sgt-At-Arms. Joe Ross and Jeff Luginbuel remain as your National Executive Committeeman (NEC) and Alternate NEC respectively.

The Resolutions Committee considered 24 resolutions during the convention. Our own Barbara Nelson submitted one and it will be forwarded to the National Convention. National Commander candidate John Brieden was a special visitor and spoke to several concerns, but the main point was to learn what we do as an organization and tell people about it. We need to

pour ourselves into The American Legion! Together we can make a difference in all areas of concern to us as veterans helping veterans and their families, helping our children, helping our communities, etc.

Next year's Department Convention will be right here in Colorado Springs at the Sheraton Hotel on South Circle, 26 - 29 June 2003. Put these dates in your calendar now and it will be very easy for you to attend.

The keynote speaker, Major General Patrick Brady, spoke to us Saturday night at the banquet. He shared many interesting facts regarding the Citizens Flag Amendment. The one I was not aware of was that both James Madison and Thomas Jefferson were against burning the American flag in protest. He also pointed out that such an act is not speech. Neither the American Legion nor I will tell you how to believe. However, it might prove worthwhile to continue your education on this subject, so that your own decision about how you feel is based on fact rather than emotion.

Department Commander Owens has selected the following theme for his year in office: UPA standing for Unity, Pride, and Achievement. His special project for the year will be homeless veterans.

**WHERE:** Palmer Park, located at the corner of Academy and Maizeland. We have reserved the Meadowlands picnic area near the kids' playground.

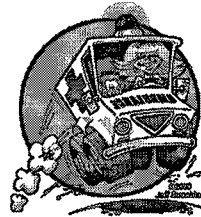
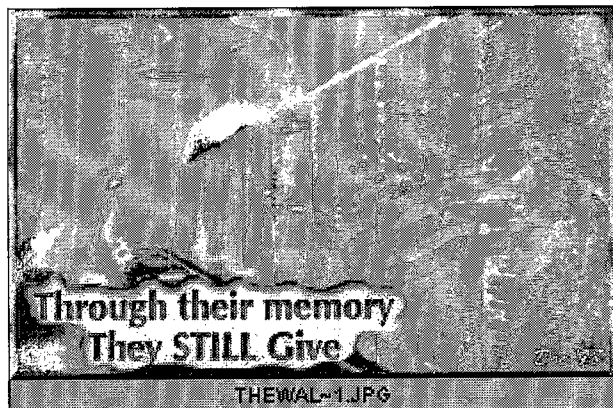
Come out and enjoy a relaxing picnic and activities such as volleyball, horseshoes, badminton and friendly discussions with friends that you know or you make.

Whereas, a complete Post home may not be feasible with costs running from \$400,000 and up, perhaps we might shoot for something more modest such as a building that could be used just as an office.
