## Benefactors

The topic of Benefactors was addressed on page 7 of last month's newsletter. For those that may have missed it – I am repeating it again on this front page for your benefit. The need still exists and is real!

My dictionary defines Benefactor as; "One who gives financial or other aid". My question to you is: do you know of someone who would be a benefactor for our American Legion Post 209. In my efforts to convince our Board of Trustees to approve the construction of a building on the lot that we own, their question continues to be, "How will we pay for it".

"Allow me to be sold bold as to suggest that perhaps other than Bingo, raffles, or sweepstakes we may know of individuals or other entities that would like to be, and would be willing

to be, benefactors for us to build a building on our lot. Whereas, a complete Post home, may not be feasible with cost running from \$ 400,000 and up, perhaps we might shoot for something more modest such as a building that could be used just as an office. In this regard my rough estimated cost would be that the costs would be much less, such as \$ 150,000 to \$ 200,000 in construction costs.

"Therefore, please check with your friends and acquaintances asking if they would know of anyone or an entity that would be willing to be a benefactor to our Post 209 for the designated purpose of building a building on our lot. ## Wanted Fund Raising Chairperson

This will be a nonpaying position but one that is desperately needed in my opinion.

Qualifications: A person who is enthusiastic, a self-starter, and able to follow through on details and be willing to run with a fund raising program for our Post 209. A quick overview of the need is as follows: We have a 7.4 acre lot that I and other members would like to see developed to include building a Post Home or a general purpose office" on it. My estimate is that we need between \$ 200,000 and \$ 400,000 or more. The \$ 200,000 is for a "Post general multi-purpose office" and \$ 400,000 or more for a" Post Home". Detailed architecture plans for a Post Home have been drawn up". However, because of a lack of funds to build they

**Adjutant Annotations**

The 2003 membership drive is moving right along, but has slowed done quite a bit since the middle of August. Last month I said the goal was 297. In the latest Department Bulletin it was announced they are changing the goal to a cutoff that is consistent with the one National used for the Department. This is an earlier date, so our goal is now 292. Fortunately, this works in our favor.

We now have 154 members. We have 33 Paid-Up-For-Life members, two new members, and the remaining 105 are renewed members. Since Department has advised they will probably not renew the Permanent Life members until October, we technically have 14 members. Using the first total we are seven away from 55% and using the second total we are one away from 48%. Either way we are well ahead of last month and that is wonderful!! Let's keep this up and make our goal by the end of December.

The 12<sup>th</sup> Annual American Legion Junior Shooting finals were very exciting this year as the level of competition was keen. For the first time all three National Offices were

present: The National Commander, The National Auxiliary Present, and the Sons of The American Legion Commander. The thirty finalists in the Sporter and Precision categories, 15 each represented the 1300 competitors that did not make it to this level. On Saturday, 10 August, eight from each category vied for National Champion. A young lady from Pennsylvania won the Precision title and a young man won the Sporter Title.

For the first time two Colorado shooters competed. Alice Trujillo of Brush, Co. and Greg Youngs of Golden were from the Colorado Gold Shooting Club. Alicia won a bronze medal in the Precision Standing category. We hope to see more Colorado shooters in the future.

At the 19 September, General meeting our guest speaker will be Millicent Young, a Women Air Service Pilot (WASP), a member of our Post. She will share with us how she became a pilot and subsequently, "Flew to be shot at, for our country".

I encourage all of our members to come and hear this unique talk. I would especially like our female members to attend.
