## **Concurrent Receipt Actions:**

Fifty-two retired Army and Air Force general officers representing 1500 years of service to the nation have signed a letter to President Bush asking him to support congressional legislation for concurrent receipt. The letter says that last year the 107th Congress passed Legislation "with overwhelming majorities in both houses" for concurrent receipt, but killed it because of White House opposition over costs, and substituted Combat Related Special Compensation (CRSC). The writer's state CRSC covers less than five percent of With a similar disabled military retirees. situation this year, the generals wrote, "We urge you as Commander-in-Chief to speak for the thousands of disabled GI's who faithfully served their country for an entire career, were disabled in service to their country and now find their retired pay taxed at a rate of 100 percent of their disability compensation. Of course, the obvious solution of many was that if we sold the property that 1). We could use the money to cover our expenses, 2). We could use the money to purchase a different parcel or building that would meet our needs now and in the future. 3). We could talk with a developer about developing the property that would also result in a building on the property and we would be able to retain a portion of the property for our use.

Myself, I feel that we as a Post have not done

everything that we could in order to support the Post and the programs of The American Legion.

You know in the past we had a money raising activity, Bingo. Irregardless of some feelings, this was a money maker for the Post and we met all of our objectives with this fund raiser. Other than Bingo and a couple of raffles we have not really done anything to raise money.

I believe that we have not done everything that we could have to help with the expenses of the Post and to build a building. During this meeting it was suggested that we could do raffles to raise money. The question that I asked was "Who is going to sell the tickets?"

## THE AMERICAN LEGION 85<sup>TH</sup> NATIONAL CONVENTION - Ann Foster

Due to another previous commitment I was only able to attend the POW/MIA Briefing, a portion of the opening day of the Convention floor, and the National Commander's Banquet that evening. I shall share with you what I am able to regarding these events.

Melvin Richmond of POW/Missing Personnel Affairs office within DOD was the speaker for the Briefing. Even though he stated he is not a statistical person, he did share with the following update of those missing: 78,000 - WWII; 8,100 - Korea; 126 - Cold War; 1,883 - Vietnam; and 1 (Capt Scott Speicher) - Persian Gulf. He reminded us this is a family issue. Efforts to bring home those missing is uppermost in their minds. In Iraq the two priorities are to find Capt Speicher and the weapons of mass destruction.

They are looking at numerous WWII sites including Papua New Guinea and Burma. They found 250 sets of remains at 36 Papua New Guinea sites.

There is to be a meeting soon in Bangkok of United States, Vietnam, Laos, and Cambodian representatives to continue pressing for a full accounting of Vietnam missing. Cambodia is fully cooperating. Laos is being difficult, but an additional problem is finding those who can speak English to assist the search teams.

Korean numbers are not as accurate as we might like. Access has been difficult due to difficult negotiations. Since 1996 there has been recovery of 176 sets of remains in North Korea.

China presents challenges in finding the missing due to needing to access archives and to wait until the SARS problem subsided.

Congress has stated money for this issue is not a problem. They will not cut money and may even want to increase this budget.

This paragraph will cover some miscellaneous information presented at the end of the briefing. Storage of remains in warehouses in Vietnam is a myth. Today's active duty computerized ID cards are a problem in terms of what an enemy could learn about us. There is no evidence to confirm transfers of prisoners from Korea to

other countries, i.e., Russia, etc. Live prisoner issue is a #1 priority, So far, none of these investigations have been successful. DNA capability to identify remains is now remarkable! Thus, family members are encouraged to donate their DNA samples. In one case their was no family member available, but an envelope the missing person had licked and sent to someone who was able to provide it to the laboratory was able to be successfully used in identifying the remains. We are all asked to tell any family member we know to please donate DNA, if they have not already done so!

Opening day of Convention saw many awards being presented and the afternoon speech of President Bush. I was unable to see that as I went with a Colorado Delegate to the VA Hospital. I am happy to report this individual is doing better.

The National Commander's Banquet was excellent and the entertainment for the evening was the Wright Brothers Band who played and sang many melodies familiar to the 50's, 60's, and 70's.
