VITAL RECORDS

If you need help obtaining certified copies of Birth, Death, Marriage or Divorce records, it is available in the guide "Where to Write for Vital Records" prepared by the National Center for Health Statistics. It list application offices, fees, and other information to help find records including how to obtain birth records for persons born in foreign countries who are U.S. citizens at birth and for alien children adopted by U.S. citizens. There is also guidance on how to get certificates of citizenship, death records of Americans who died abroad and records kept by foreign countries.

To get a copy, send a check or money order for \$1.25 to the Supt of Documents, Washington D.C. 20402, and include the Government Printing office stock number 017-022-00847-5. Orders may also be charged to VISA or MasterCard. For faster service, charge orders may be placed by calling (202)783-3238.

GRANTING POWERS OF ATTORNEY:

Generally a Power of Attorney is a document through which one person authorizes another to transact business for him to the extent set forth in the Power of Attorney. But while powers of attorney are sometimes useful, they can't accomplish many of the things most people think they can for a number of reasons. First nobody is compelled to accept the power of attorney, even though it is legally acceptable. Many will refuse to accept a power of attorney simply because they are uncertain of the validity of the document. Also, many businesses or institutions will accept a power of attorney only if it is in a format prepared by them. Second, powers of attorney are revoked by the death of the grantor.

There are two types of powers of attorney: general and special. A general power of attorney is designed to grant the named person authority to accomplish nearly every transaction the grantor could accomplish. The fact that it gives such a broad authority makes it somewhat risky because the grantor has no control over what it is used for. Because it provides such a broad authority, a general power of attorney should be executed only under the most compelling circumstances and should name only a person in whom the grantor has total confidence.

The special power of attorney authorizes the named person to act for the grantor in a single transaction.

Some states have power of attorney stipulations: for example, under Texas law the buying and selling of real property (land, houses, buildings) requires a special power of attorney which contains the legal description of the property.

C & Y PROGRAM LEADERS SET AREAS OF CONCERN FOR 86-87:

Participation with the communities in American Legion projects for the benefit of local children and youth continues to be a source of great satisfaction for Legionnaires and members of the American Legion Auxiliary.

Many important services are provided through such annual programs as April is Children & Youth Month, Special Post Activity Awards (STAR), Temporary Financial Assistance (TFA), Family Week, Special Olympics, The Holloween Safety Program, and many other outstanding activities.

After weighing the many important issues facing our youth today, the National Commission on Children & Youth determined that there were no problems more pressing than the three major areas of concern which the Legion has been emphasizing.

Because of its continuation in these area, the Commission has established for the American Legion a high level of credibility with other national organizations specializing in these areas. The Legion is now a part of many important national networks that recognize our contributions in these areas as highly significant.

The major areas of concern for the 86-87 program year will continue to be as follows:

TEENAGE SUICIDE PREVENTION: Today the American Legion is recognized as a leader in this area of concern. Many community officials have requested materials prepared by the Legion for their educational programs. Many post have taken this program into the schools and drawn greater public awareness to the problem with the cooperation of local news media.

Every request for material received at National Headquarters is not only filled with some excellent program material but also is accompanied by a media kit. This kit contains slides (for T.V. use) news releases, proclamations, and other media material to help the volunteers in the development of a local program for the

prevention of teenage suicide.

As long as some teenagers continue to look for a permanent solution to a temporary problem through suicide, the American Legion must take a leading role in raising the banner of hope through effective prevention programs.

MISSING CHILDREN: Major emphasis in this area of concern is prevention through education. The American Legion provides two brochurs that are in great demand concerning this problem. The newest of these is the first of its kind for the commission. In the past, our material had been aimed at an adult audience. The new brochure - Children Beware _ is designed for children. The brochure is targeted at elementary age students. National distribution is scheduled to begin this fall.

DRUG ABUSE PREVENTION: The only solution to reducing illegal drug traffic is to dry up the demand. Through effective educational programs, we can help our youth make responsible decisions about their use of drugs.

This is not a problem that is destined to disappear on its own. The use and abuse of illegal drugs continues to plague our society as it swallows the future of many young people.

Through the use of our educational material addressing the issues of drug abuse prevention, alcohol, and marjuana, your American Legion Post can have a positive impact on your community. Just by showing that you care may keep one life from traveling the dead-end street of drug abuse.

LABOR DEPARTMENT PROPOSALS THREATEN VETERAN ASSISTANCE:

Washington (ALNS) - Potential changes in the U.S. Department of Labor's Employment Service could mean the loss of an important protection the nation's veterans have received since 1933, warns the American Legion. In a letter to Secretary of Labor William Brock, National Commander Dale L. Renaud has requested the department to delay any change in the Employment Service until veterans organizations are consulted.

The passage of the Wagner-Peyser Act of 1933 provided for veterans preference as millions of Americans looked to their state employment service for assistance in obtaining jobs. The concept of veterans preference was reconfirmed and reemphasized with the passage of the Veterans Readjustment Act of 1944 (The GI Bill of Rights) and by subsequent legislation over the years.

As it now exists, the Employment Service receives funds from the federal government, along with guidelines about how the funds are to be used. Being considered is the "New Federalism" approach of sending funds to the states as a type of block grant, with few restrictions on its use. States would then be free to run their programs as they saw fit, and not be required to give veterans the preference they now enjoy.

"States tend to view veterans as a federal problem," said the Legion's Economic Director, Dennis K. Rhoades. "Most believe, mistakenly, that the Veterans Administration provides employment and training assistance for veterans. It's just not so; it's the labor departments job."

Rhoades emphasized that the Labor Departments plans will leave the Department and Veterans it is supposed to serve with no delivery system for job placement and training services.

In his letter to Secretary Brock, Commander Renaud ask him to agree to meet with American Legion representative to ensure that this critical program for veterans is not diminished.

VA INSURANCE HOAX CONTINUES TO HAUNT VETS:

Washington D.C. (ALNS) - It is a hoax that will not die. Yearly now, more and more veterans are receiving notices that an insurance refund to veterans of World War II is available. There is no truth to the information contained in the notice.

There are no insurance refunds like this, said Philip R. Wilkerson, Assistant Director for claims of the American Legion. "It's not exactly a case of fraud or a scam, because nobody makes money. But the administrative costs to the Veterans Administration are enormous."

Wilkerson pointed out that the VA has to assign staff to answer the thousands of requests which follow the circulation of such notices. "The VA's already strapped enough, without having something like this to worry about," he said.

The mininformation surfaces in different parts of the country on a regular basis, and has plagued the VA since the 1950's. "This is one of those instances which sounds to good to be true and it is," Wilkerson said.

PLUS TO BATTLE ADULT ILLITERACY:

The American Legion from the early days of its founding in 1919, has been - and will continue to be - concerned about the problem of illiteracy. This is a problem which not only presents a staggering cost to the nation in terms of dollars and cents, but also poses a threat to the nation's strength.

For the millions of Americans who cannot read a street sign, a warning label, or a job application, illiteracy is a personal tragedy. For the nation, the cost of illiteracy runs into billions of dollars.

Federal studies estimate that at least 23 million adult Americans are functionally illiterate - with basic skills at 4th grade level or below. Another 35 million are semi-illiterate with skills below the 8th grade level. And those numbers are growing.

Let's take a look at what your post can do in your community to help eradicate illiteracy.

The main purpose of a sponsor, such as your post, is to provide reasonable support of a literacy program which will help ensure its stability and continuity. The degree of involvement with the day-to-day operation of the program will vary greatly, but sponsors should provide some of the following kinds of assistance:

*Publicity to raise community awareness of the problem (this is one of the purposes of PLUS) and the program (purpose of PLUS task force).

*Assist in the recruitment of leaders, tutors, and students (check your membership rolls; you may have members who fit all of these categories).

*In-kind services such as clerical help, office space and/or equipment, duplicating services. (Does your post have unused or older equipment which can be refurbished and donated to the program? Is there room in the post building for classes?)

*Expertise in a specialized area, such as public relations or planning financial management.

*A representative to participate in the program's governing body (someone to see that the post's resources are utilized correctly and to maintain awareness of the continuing needs of the program).

There is also a national source for help. This number also can be used by adults wishing to be referred to a program in their respective area.
