Commanders Comments:

ITEM 1: We had a most fruitful meeting on 15 Sept. . . It was well attended by our standards. Thanks for coming out and let's have more participation in the future. Believe me when I say that your "two-cents" are worth a pound of gold when it comes to you becoming an active Legionnaire.

ITEM 2: I would like to ask that any Legionnaire that has not renewed their 1989 membership to do so now. You will be receiving a second Notice some time after the First of October.

ITEM 3: On 20 Sept. I attended the district Seven Fall Conference at Post 5. Again the attendance was above average. Several Department Officers including Neal Thomas, the Department Commander, were there to brief us on the National Convention results recently completed in Louisville, Ky. The Department Commander made awards to the District and District Posts for their outstanding Performance in various activities. Our Past District Commander, Larry Johnson earned a jacket for his membership activities, Our Post Commander, John Kovar, also won a membership jacket, in addition pins and medallions were awarded to Bob Morris and Tom Bender. These will be presented to the recipients at our 20 October meeting.

ITEM 4: At the recent Veteran Recognition Day at Fort Lyon VA Hospital we presented a check for \$500.00 to the Administration in the name of John Gaillard our deceased comrade, to be used on projects the hospital administration deemed most worthy of support. While there, the administration presented a "WISH LIST" of patients needs. Their list included many things from a special van to note paper. One area that caught my fancy was the request for coats, toiletries, clothing (mens) socks (without the elastic tops) pants, shirts, underwear and luggage type bags or suitcases that the patients can use to carry their meager belongings when they are discharged. Many of the patients arrive for treatment or admittance with only the clothes on their backs and a brown paper bag with a few personal items. I would like to suggest to the Post and Auxiliary that we collect on a continuing basis, items such as these from our own households and that when we collect enough we pack and ship these items to the Hospital. I'll have a suitable container available whenever the Post Home is open. Let's do it for the good of those veterans who are down on their luck and in poor health.

ITEM 5: It was resolved at the last meeting that 25 per cent of our Bingo Profits be designated in a distinct Building Fund Account devoted to acquiring land and/or building for our permanent home.

ITEM 6: Our lease agreement is in the hands of the owners and Bob Morris says that our going for a straight five (5) year lease at the "agreed-to" price should present no problems since it meets his management's request of not including a three (3) year option.

ITEM 7: ACTIVITIES REQUIRING MEMBER PARTICIPATION:

THE AMERICAN LEGION NATIONAL HIGH SCHOOL ORATORICAL CONTEST: HISTORY AND PURPOSE

William A Kitchen, a Past Department Commander of Missouri, is credited with originating The American Legion's National High School Oratorical Contest. He experimented with the contest in a few high schools in and around Kansas City, Missouri, during the school year 1934-1935. He became the first Department of Missouri Oratorical Contest Chairman and conducted a state-wide program during the 1935-1936 school year.

From this beginning, he encouraged the American Legion to adopt the Missouri Oratorical Contest plan as a National Program. The first national contests were held in 1938, with 11 Departments competing and 4,000 students participating. The National finals that year were held in Norman, Oklahoma, with John Janson of Phoenix, Arizona, taking first place honors.

Since its inception, the contest has awarded well over \$ 1 million in scholarships to the participants at the National level of competition. Many thousands of dollars in scholarships have been awarded at Post, District, and State levels.

The National High School Oratorical Contest was developed primarily to install a better knowledge and appreciation of the Constitution of the United States in high school students. Other objectives include the development of leadership qualities, the ability to think and speak clearly, and the preparation for acceptance of the duties, responsibilities, rights and privileges of American citizenship.

The American Legion takes great pride in the contest and a strong interest in the contestants and their families. For this reason, participants have cited the experience of meeting people involved in this program as a special benefit of the competition. Entrants reaching advanced levels of the contest have the added chance to meet students and veterans from throughout the nation.

From the 1938 Contest the annual student participation has grown to some 30,000 students representing 53 Departments throughout the Nation.

The only National Winner for the Oratorical Contest for the Department of Colorado was Dean F. Clancy from Denver who shared this winner spot with Marlene Van Dyk from Grand Rapids Michigan in the 1981 contest. This was the only time that two winners have been declared since its origin.

The subject of course is the American Constitution and the contestants have to prepare and give two speeches a prepared oration and an extemporaneous discourse.. The prepared Oration is a prepared oration on some phase of the Constitution of the United States which will give emphasis to the attendant duties and obligations of a citizen to our government. The prepared oration must be the effort of each contestant and must not take up less than eight minutes or more than ten minutes for delivery.

The extemporaneous discourse must not consume less than three minutes or more than five minutes for delivery. The purpose of this portion of the contest is to test the speaker's knowledge of the subject, the extent of the research, and the ability to discuss extemporaneously the topic related to the basic principles of government under the Constitution.

Scholarships are as follows. 1st place \$16,000, 2nd Place \$14,000, 3rd place \$10,000 and 4th place \$8,000 for the national winners.
