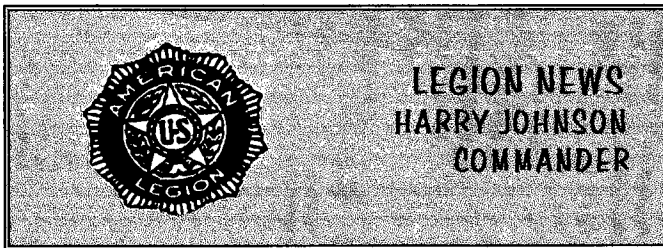

ADJUTANT'S ANNOTATIONS - ANN FOSTER

Our membership for 1997 is now 187. As the Commander said, this is not good. We are a little over 35% of our goal of 501. We need 200 for 40%. If this Post is to continue its mission of veterans helping veterans, we are going to have to do better in our membership.

Convention in Salt Lake City was very interesting, my first trip to that location. Our quarters were two blocks over and two up to the Convention Center. Sounds good but their blocks are big. Between that and the huge space inside the Center, I more than met any aerobic goals for walking.

I attended the Legislation Committee meeting. It had no resolutions to submit to the Convention body but urged all to continue to let your representatives know how you feel about veterans issues and reminded everyone to vote. The main speaker for this meeting was Mrs. Melanie Bowen, State Director of Senator Orrin Hatch's office. She gave an excellent presentation on how to get involved in the legislative process.

I also attended the POW/MIA update. There were three speakers - Carl Ford, formerly of the CIA, who thanked The American Legion for standing firm on POW/MIA issues. Ford said that he has been angry and frustrated for the last three years about what the government has been saying. He specifically stated, "It is shameful. At worst they may have made it possible for the families to lose out on finding out anything more. They seem to be willing to say whatever will justify the end means." Ford also thanked John Sommers, Executive Director of the Legion's Washington, D.C. office and all the young people on the Task Force looking for remains.

Dino L. Carluccio, Legislative Assistant for Senator Bob Smith (R-NH), was the next speaker. He stated that no other veterans group has shown more concern for this issue. He also praised the work of the Task Force. Carluccio pointed out no one has said what happened to Americans captured in northern Laos. Pressure needs to be maintained. Vietnam still thinks it can get away with not providing us what we want.

Brig Gen James L. Campbell, head of the Task Force spoke next, presenting a most impressive slide briefing on how they accomplish their mission. There have been 370 remains repatriated and 121 U. S. identifications completed. They have good reason to believe 582 remains are not recoverable.

The main convention started with Tony Orlando entertaining us. He also did a show the night of the Commander's Banquet. Several major figures gave presentations throughout the Convention, such as Senator John McCain, Jesse Brown, Rep James B. Langley Jr of Maine (he introduced the GI Bill of Health in Congress), Rep Steve Buyer of Indiana (member of House Veterans' Affairs Committee), Bob Dole and Ross Perot. There were many reports given and awards presented.

All of the above means The American Legion is alive and continuing to "Still Serve America." However, this excellent work can only go forward if we do as Commander Johnson has suggested. We need to accept our responsibility to being active participants at whatever level we are able to perform.
