

ADJUTANT ANNOTATIONS - ANN FOSTER

Last month I reported that we might have a new membership goal of 401 due to adjustments within District 7. It now appears that I misunderstood or misinterpreted that number given in a quick meeting after Fall Conference. So I am going to give your membrship results from the standpoint of our old goal of 501, as well as the new goal of 401, and in the meantime correctly determine the new goal (probably somewhere between).

We now have 225 membership renewals, new members and some transfers. With a goal of 501 we would one away from 45%; with the 401 goal, we are at 55%. We would need 16 more for 60% under this plan. Obviously, it is to our advantage to have a lower goal than 501. We are still faced with the need of members, regardless of the goal.

I would like to ask your support of the survey submitted by our Post Commander Harry Johnson. This Post cannot proceed very well without your guidance. The Executive Committee needs to know how you feel about the future of Post 209. Why did you join The American Legion and what are your expectations of it at any level: National, Department, District and Post? Even if you have none, other than a card and the various Legion publications you receive, please tell us that also so we have some idea of how to plan for the future.

I was privileged to see our National Commander during his recent visit to Colorado. Commander Ludwig gave us some very basic things to think about concerning The American Legion and what we stand for, as well as what we believe. His theme this year is "Still Serving America," and that is what it is all about. To do that better and to support that theme, membership must be increased. (You can see your Post is not the only one concerned with that issue.)

Commander Ludwig also stated The Citizens Flag Amendment should be passed if "We, the People," really means what it says. He also believes our founding fathers meant this document to be able to live as our country developed. Hence, the provision for amendments.. He further stated it would be a very sad day if the amendment does not pass. I

think that would be true for a majority of this country. If you are formerly from a state having Senators who are opposed to this amendment, contact them and ask for their support. Remind them this is a national issue, that approximately 80% of the people want this amendment.. They should feel an obligation to support it on behalf of their constituency, regardless of how they personally believe.

We are planning to have an initiation of new members at our General Meeting next month. This is a very nice ceremony, and we would like as many as possible to participate. 
