Next to me was a young veteran in a wheelchair, his wife and two small children were there too, braving the cold, snow and wind to give tribute to our veterans and active duty men and women who served, and continue to serve our country. It was a time to thrill us as American flags

were carried by and to see those who marched, rode and walked in the parade. They represented so many that served throughout our nation's history. All appeared to be proud and in good spirits. Men and women who served in the Korean War 50 years ago and those from Fort Carson returning from peace keeping missions were particularly being honored this Veterans Day.

Norman Moyer, Junior Vice Commander was near the reviewing stand videotaping the parade. A photographer took our Commander's picture and it was published in the Colorado Springs Gazette newspaper Sunday, November 12.

Overall the parade lasted a bit more than an hour, with various military units (over 3,000 Fort Carson soldiers marched) and high school bands bravely playing patriotic marching songs, Jr. ROTC units, along with Boy and Girl Scouts and leaders, made this parade worth being there. Hats off to the Pikes Peak Veterans Council, organizers of the parade this year.

Other Veterans Day events also took place November 16<sup>th</sup>. Post 209 Early Bird dinner did take place that date at the Post 5 home. Larry Johnson, Post Judge Advocate, along with the Post 5 Commander, prepared an excellent meal for the enjoyment of some 30 members and guests. **ADJUTANT ANNOTATIONS**  
**ANN FOSTER**

As we head into December, we now have 226 members towards our goal of 270 for the upcoming Legion year. That is very close to 84%. Thanks to everyone who has renewed and we look forward to getting the rest of you signed up soon. It would be such a very nice thing to have this all done by 31 December.

We have had a request to enlighten newer members about our Board of Trustees, as per our Constitution and By-Laws. The Constitution portion is short, so I will quote it.

**"Article V Board of Trustees**

Section 1 - The board of trustees shall be incorporated as the official body representing American Legion Centennial Post 209, Department of Colorado in all legal and binding agreements. The board is empowered to enter into contracts, mortgages, and other fiscal instruments as the official authority of the Post. The Board derives its power to act on behalf of the Post by approval of resolutions authorizing the pertinent activity. The authority may be limited only to the action to be taken, the best method of action to be determined by the board.

Section 2 - All members of the Board of Trustees shall be bonded and governed by state and federal regulations pertaining to the administration of sound business practices. It shall further be the responsibility of all members

of the Board of Trustees to act judiciously in the execution of all duties to enhance the image of the American Legion.

Section 3 - Selection for membership to the Board of Trustees and the conduct of meetings of the Board of Trustees will be governed by the by-laws of American Legion Centennial Post 209."

In the by-laws the membership of the Board of Trustees, how they are elected, how long they serve, how to fill vacancies, how to remove a member if deemed necessary, and how the meetings are to be held is covered. Since it is longer, I will try to hit the high spots. Please remember that the Constitution and By-Laws are always available to anyone desiring to study them. The board of trustees shall consist of seven members. This will include the current Post Commander and the current Post Finance officer and five elected members. No member may be elected to the Board who has not been a continuous member of the Post for five years. At least three of the five elected members, other than the current Commander and Finance Officer, must have successfully completed at least one term as Post Commander of American Legion Post 209.

Election of members for the Board of Trustees will be at the Post General Elections. At the first election the term length of offices was staggered for purposes of future continuity. Those elected in succeeding years serve for three years.

A meeting of the Board of Trustees will be held during the first week of July of each year and monthly thereafter. At this time the Board meets the same night as the Executive Committee meeting at the Post Home. Anyone may attend these meetings at any time.

Currently the following individuals are members: Commander Francis Redington, Finance Officer Al Cyriaque, Past Commander Harry McFadden, Past Commander Larry Johnson, Past Commander Neal Thomas, Past Commander Harry Johnson, and Norm Harpole. Please feel free to contact any of these members at any time with any questions or concerns that you may have, particularly those having to do with a future Post Home.
