**Happy Holidays**

The Board of Trustees & Executive Committee extend Holiday Greetings to all in our American Legion Family. May good health and peace be with you and yours.

**Update on Lot Development/Sale.**

Several offers have been received for our Post 209 lot. Action and responses to these offers are pending due to the lack of having a quorum at the General Membership meetings. In put from a quorum of members at meetings is needed for the Board of Trustees and Executive Committee to know what the membership desires.

**Constitution & Bylaws**

The November 2003 newsletter indicated a vote would be taken at the November 20<sup>th</sup> regular General Membership meeting to amend the current Bylaws of the Post's Constitution. The purpose was to change the Bylaw requirement stating that: **"10% of the membership in good standing shall constitute a quorum for the conduct of business at a regular or special meeting."**

Sixteen (16) members were present at the November 20<sup>th</sup> regular General Membership Meeting. Twenty-nine (29) members were needed to be to have a quorum of 10%.

Please note that Post 209 Constitution, Article IX, Section 2, states:

***"This Constitution may be amended at any regular post meeting by vote of two-thirds of this (the) members present and voting, providing that the proposed amendment shall have been submitted in writing and read at the next preceding regular post meeting, and providing further that written notice shall have been given to all post members at least ten days in advance of the date when such amendment is to be voted upon, notifying such members that such meeting a proposal to amend the Constitution is to be voted upon."***

Attendance records show that the 10% quorum requirement has been met twice in 1991, once in 1992, and once in 1993. And, not once since based on a projected membership of 285.

Obviously, this is not a good showing! It is most difficult, and frustrating, to operate as a member directed Post when a quorum of members is not present at meetings. It therefore, seemed logical to make a change in the Bylaws as to what would constitute a quorum at meetings.

The proposed amendment was presented and read at the October 2003 regular General Membership meeting, and notice was give to members via the November 2003 newsletter. Thus meeting Post 209 Constitution & Bylaws requirements.

Discussions were held at the November 20<sup>th</sup> meeting to change the requirement for a quorum from 10% to 4% or 5%. Agreement was not reached and the proposed amendment failed. Therefore, since the 16 members present did not constitute a quorum, the meeting was adjourned.

Post 209 is in somewhat of a quandary should members continue not to attend meetings. The Executive Committee is left to use their discretion in the conduct of the necessary business.
